135 Crash Description

The driver of vehicle #2 stated she was attempting to turn left out of the parking lot of 2098 Rt. 88, on to Rt. 88. She stated she was stopped behind another vehicle, waiting for her turn to proceed forward. She stated as she was stopped, vehicle number one backed out of a parking space and struck her vehicle.

The driver of vehicle #1 stated he was backing out of a parking space in the parking lot of 2098 Rt. 88. He stated he never saw vehicle #2 directly behind him and began to back up. He stated vehicle #2 came speeding across the parking lot causing him to strike vehicle #2.

My investigation revealed that vehicle #1 was at fault for failing to observe vehicle #2 directly behind him.

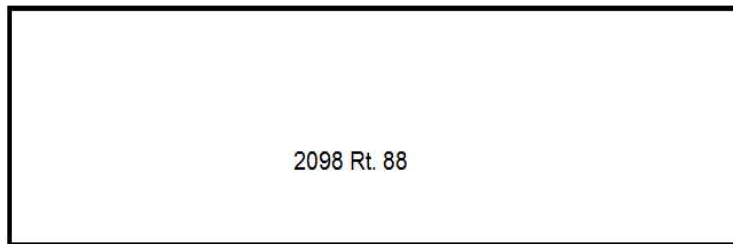
No injuries reported. Minor damage to both vehicles.
