Driver #2 stated that he was on Midstreams Place at the stop sign when vehicle #1 struck the left side of his vehicle.

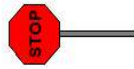
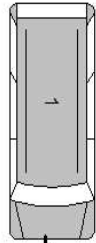
