135 Crash Description

Vehicle 2 traveling westbound on Route 88, approaching John Street, attempting a right turn into the parking lot of Home Depot, 1722 Route 88. Vehicle 1 traveling straight ahead, directly behind Vehicle 2.

Driver 2 stated he had signaled a right turn as he approached the entrance to 1722 Route 88. Driver 2 stated just prior to making his turn, checked his rear view mirror and he could see Driver 1 looking down. Driver 2 stated as he slowed and started his turn, he was struck from behind by Vehicle 1.

Driver 1 stated she was traveling eastbound on Route 88, behind Vehicle 2. Driver 1 stated as Driver 2 was making his turn, she thought she had enough room. Driver 1 stated she began to go around him when she struck the rear of Vehicle 1.
