135 Crash Description

Investigation at the scene indicated the following: Vehicle 2 traveled south on Jack Martin Boulevard and vehicle 1 was directly behind vehicle 2. As vehicle 2 approached 515 Jack Martin Boulevard, the driver observed a vehicle stopped in the road way and vehicle 2 swerved to the right to avoid a collision. Vehicle 1 also swerved to the right and struck the rear of vehicle 2 with the front of the vehicle.

I spoke to driver 1 on scene and he stated the following:

He was driving directly behind vehicle 2 while on Jack Martin Boulevard. Vehicle 2 swerved to the right and stopped on the shoulder of the roadway. Driver 2 also swerved to the right of the roadway to avoid collision with vehicle 2 but was unable to. The front of vehicle 1 struck the rear of vehicle 2.

I spoke to driver 2 on scene and he stated the following:

As he traveled south on Jack Martin Boulevard, he observed the vehicle in front of him stop in the roadway with its left turn signal on. Driver 1 turned his wheel to the right to avoid collision and he stopped on the shoulder of the roadway. Vehicle 1 also swerved to the right and struck the rear of vehicle 2 with the front of the vehicle.

Driver 1 was at fault for the accident and I issued him a summons for Careless Driving (E16002661).
