## 135 Crash Description

Vehicle 1 was in the middle lane on Rt 70 East bound approaching Jack Martin Blvd, slowing down for traffic ahead.

Vehicle 2 was stopped in traffic on Rt 70 East bound, also in the middle lane but was stopped for traffic ahead.

Vehicle 1 was unable to stop in time and collided with the rear of vehicle 2, there were no reported injuries at the scene and minor damage was observed to both vehicles.

The driver of vehicle 1 stated that he was traveling East on Rt 70 approaching Jack Martin Blvd and began to slow down for traffic ahead of him but was unable to stop in time and collided with the rear of vehicle 2. Vehicle 1 was a commercial vehicle and was insured by Acord Insurance from Everest Indemnity Insurance Company with a NAIC# of 10851 out of J.S. Braddock Agency 22-North Main St Medford NJ 08055.

The driver of vehicle 2 stated she was stopped in traffic on RT 70 East bound in the middle lane when vehicle 1 collided with the rear of her vehicle.
