135 Crash Description

Driver of Vehicle 2 stated she was traveling on Route 88, attempting to turn left on Hoover Drive. She stated while she was waiting, Vehicle 1 struck her from the rear.

Driver of Vehicle 1 stated she was traveling behind Vehicle 2, east on Route 88. She stated Vehicle 2 stopped abruptly, forcing her to crash into the rear of Vehicle 2.

Vehicle 1's front bumper struck Vehicle 2's rear bumper, causing significant damage to both vehicles. Vehicle 1 was disabled and left in the roadway.

Driver of Vehicle 1 was checked out by Brick Police EMS and refused medical attention. Rear passenger of Vehicle 2 had a minor head laceration to the back of his head. Driver of Vehicle 2 requested all passengers to be transported and medically checked out. Driver of Vehicle 2 and both passengers were transported to Ocean Medical Center.

No further injuries were reported at the time of this report.
