135 Crash Description

Vehicle 1 was traveling in the parking lot of Walmart (1872 Route 88) at the exit onto Jack Martin Boulevard. Vehicle 2 was traveling straight ahead along Jack Martin Boulevard heading south from the intersection of Route 70. Vehicle 1 proceeded onto Jack Martin Boulevard south from the exit of Walmart and failed to yield the right of way to Vehicle 2. Vehicle 1 subsequently impacted the passenger side of Vehicle 2 causing the collision.

Driver 1 stated that she stopped at the stop sign at the exit of Walmart then proceeded without seeing Vehicle 2 approaching. Driver 2 stated that he was going straight ahead and observed Vehicle 1 disregard the stop sign at the exit of Walmart and was unable to avoid Vehicle 1.

No injuries were reported on scene and both vehicles were able to be driven away. As a result of this crash investigation, it was determined that Driver 1 was the at-fault party and a summons was issued for Failure to Stop/Yield Right of Way (39:4-144, E16-001907).

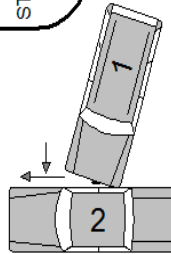
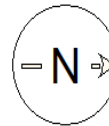
Motor Vehicle Crash Diagram
