135 Crash Description

Investigation revealed vehicle 1 rear ended vehicle 2 causing a chain reaction crash on Rt 88 approximately 50 feet east of Van Zile road. The force of the impact from vehicle 1 colliding with vehicle 2 pushed vehicle 2 into the rear of vehicle 3.

Driver vehicle 1 stated he made a left turn onto Rt 88 from Van Zile and began to accelerate. While accelerating, driver vehicle 1 briefly looked to his left towards St Dominic's. When driver 1 looked forward again vehicle 2 was stopped in traffic directly in front of him. Driver vehicle 1 attempted to brake but was unable to before rear ending vehicle 2.

Driver vehicle 2 stated he was stopped in traffic behind vehicle 3. Traffic ahead of the vehicles was stopped for a school bus with its red flashers displayed. While stopped, vehicle 2 was rear ended by vehicle 1. The force of the impact pushed vehicle 2 into the rear of vehicle 3. Driver vehicle 2 added driver vehicle 3 provided his name and address and left the scene.

I observed vehicle 3 drive away from the scene. Ptl. Prendeville #223 was able to locate and stop vehicle 3. Driver vehicle 3 stated he had minimal damage and did not wish a report.

I observed vehicle 1 to have minor damage to the front bumper, including the front license plate knocked off the vehicle. Vehicle 2 had moderate damage to the rear bumper including the imprint of vehicle 1's license plate in the bumper, as well as, moderate damage to the front bumper and hood. Ptl. Prendeville advised vehicle 3 had minor damage to the right rear bumper. No injuries were reported on scene.
