145. Crash Description/Narrative

Vehicle #2 was traveling on Route 88 eastbound, near the intersection of Edge Street. Vehicle #1 was traveling directly behind vehicle #2. Vehicle #1 attempted to pass vehicle #2 on the shoulder and struck the passenger side of the vehicle. Due to the impact, vehicle #1's right front wheel struck the curb.

Driver of vehicle #2 stated she was traveling on Route 88 eastbound, near the intersection of Edge Street. She had her left turn signal activated, to signal she wanted to turn into one of the near by parking lots. She was not from the area and did not know exactly where the parking lot entrance was located. While continuing straight ahead, with her signal still activated, vehicle #1 attempted to pass her on the shoulder. At that time, vehicle #1 struck the passenger side of her vehicle.

Driver of vehicle #1 stated he was traveling directly behind vehicle #2. He observed vehicle #2 having their left turn signal activated, signaling they were going to turn into the parking lot. He attempted to pass vehicle #2 on the shoulder and vehicle #2 continued traveling straight ahead. At that time, his vehicle struck the passenger side of vehicle #2. The impact caused his right front wheel to strike the curb.

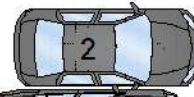
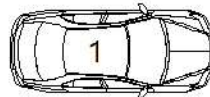
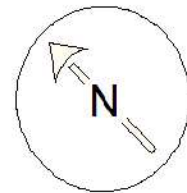
