145. Crash Description/Narrative

I was dispatched to 1872 Route 88 in reference to a two car motor vehicle collision.

Upon arrival, I appeared as though V 01 was backing out of a parking stall and backed into the rear bumper of V 02.

I spoke with the driver of V 01 who stated the following: She was backing out of a parking stall and did not see V 02. She backed into the rear left bumper of V 02.

I spoke with the driver of V 02 who stated the following: He was stopped waiting for his relatives to exit Walmart. V 01 then backed into his rear bumper while he was stopped waiting.

After my investigation it was determined V 01 was at fault for unsafe backing. No injuries were reported on scene.

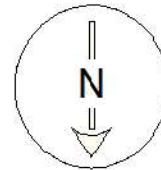
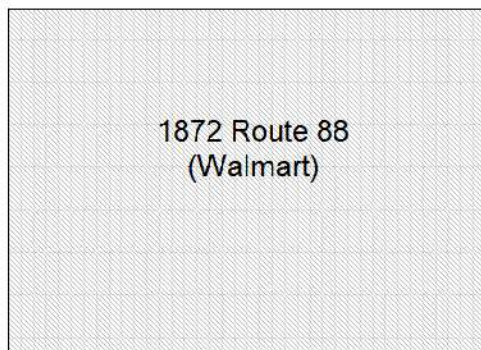

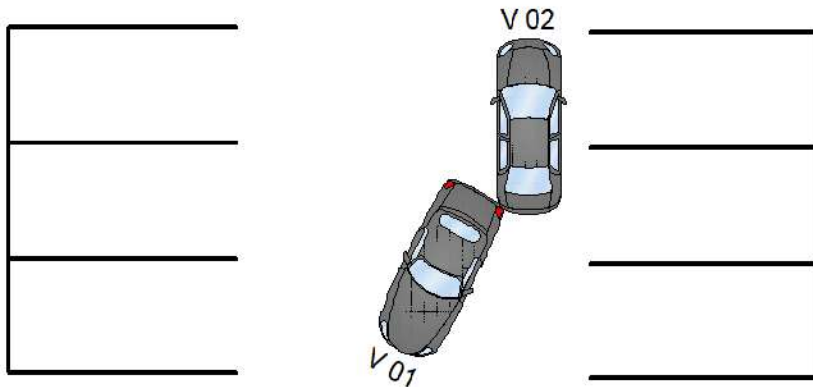
