145. Crash Description/Narrative

I responded to the area of Route 70 east and Jack Martin Boulevard in reference to a two car motor vehicle collision. Upon arrival, I observed a two car same direction rear end motor vehicle collision. I appeared as though V 01 rear ended V 02 while in the jug handle from Route 70 east leading to Jack Martin Boulevard.

I spoke with the driver of V 02 who stated the following: He was slowing to stop at the yield sign to allow vehicles to pass before entering Jack Martin Boulevard. He was then rear ended by V01. There was a minor indentation on his right rear bumper that he claimed was not there prior to the accident. He had complaint of pain to his back, stating he felt a jolt when he was struck.

I spoke with the driver of V 01 who stated the following: He was following behind V 02 and accidentally rear ended him. He admitted to being at fault and apologized for his mistake. I did not observe any damage on V 01.

The damage claimed on V 02 did not appear to be consistent with this type of motor vehicle collision.

After my investigation it was determined V 01 was at fault for following too closely.
