135 Crash Description

Crash occurred at the intersection of Rt 88 and Post Rd.

Driver #2 stated she was traveling east on RT 88 in the right lane approaching the intersection with Post Rd. She stated she had a green light and was continuing straight when vehicle #1 made a left turn in front of her. She advised she could not stop in time and the two vehicles collided.

Driver #1 stated she was traveling west on RT 88 in the left lane. She advised she came up to the intersection with Post Rd and had the green light. She stated she thought it was clear and proceeded to make a left turn onto Post Rd. and was subsequently struck by vehicle #2.

The impact from the collision spun vehicle #2 around, 180 degrees and vehicle #1 ended up striking a curb and resting against a traffic light pole. There was no damage to the traffic light; however the grass near the curb, belonging to Lawrence Realty Century 21, was damaged.

Driver #2 had complaint of stomach, right ankle/foot and head pain. She was also bleeding from the head. She was treated on scene by first aid and subsequently transported to Jersey Shore Medical Center for further treatment.

Driver #1 had complaint of pain in her chest and a large laceration to her left ankle. She was treated on scene by first aid and subsequently transported to Ocean Medical Center for further treatment.

Vehicle #2 was towed by D&L Towing.

Vehicle #1 was towed by Frank's Towing.

A witness on scene provided a witness statement form which indicated vehicle #1 made a left turn in front of vehicle #2.

Driver #1 was issued summons #: T151282 for failure to yield right of way to oncoming traffic, 39:4-90.
