## 135 Crash Description

Vehicle 2 traveling westbound on Route 70 approaching intersection with Van Zile Road. Vehicle 1 traveling westbound on Route 70 directly behind Vehicle 2.

Driver of Vehicle 2 stated that she stopped in traffic due to a vehicle stopping abruptly in front of her. As she came to a stop Vehicle 1 was unable to stop and crashed into her vehicle from behind.

Driver of Vehicle 1 stated that a vehicle cut in front of Vehicle 2 causing it to stop. Driver of Vehicle 1 stated he was unable to stop in time and crashed into the rear of Vehicle 2.

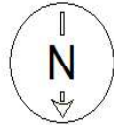
Based on my investigation and observations on scene I determined Vehicle 1 to be at fault for the motor vehicle crash.

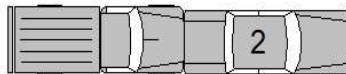
