135 Crash Description

On scene investigation concluded: Vehicle #1 was entering the Ocean Medical Center off of Jack Martin Blvd. Vehicle #1 made the right turn, slid on the wet road surface and struck the curbed median in the parking lot entrance causing damage to the undercarriage of the vehicle.

Driver of Vehicle #1 stated she was making a right turn into the Ocean Medical Center when her vehicle began to slide resulting in her vehicle striking the curbed median.

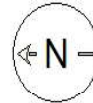
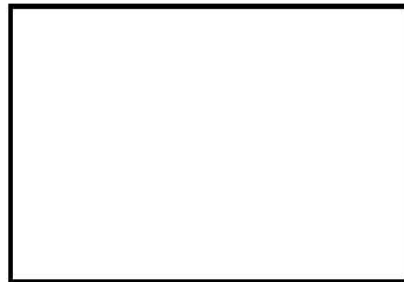

Motor Vehicle Crash Diagram

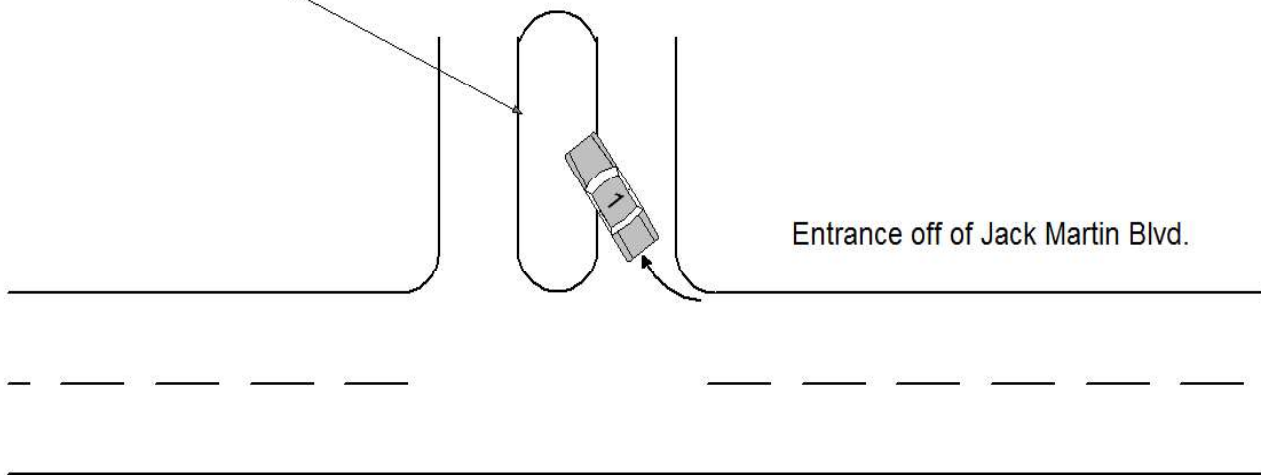
