135 Crash Description

The driver of vehicle 1 advised he was traveling east on Route 88 approaching Post Rd when the front of his vehicle collided with the driver's side middle of vehicle 2 which was making a left onto Route 88 from Post Rd. The driver advised he did not observe the signal and continued into the intersection.

The driver of vehicle 2 advised she was attempting to make a left turn onto Route 88 from Post Rd when she proceeded into the intersection as she had the green light. The driver advised as she proceeded into the intersection the driver of vehicle 1 ran the red light and collided with the driver's side middle of her vehicle.

The driver of vehicle 2 was transported to the Ocean Medical Center with a complaint of chest and wrist pain.

Vehicle 1 sustained damage to the front while vehicle 2 sustained damage to the driver's side middle.
