135 Crash Description

Vehicle 1 and 2 were traveling in the lot of Walmart (1872 Route 88) with Vehicle 1 parked in the 5th space from the main thoroughfare in Row #8 and Vehicle 2 parked in the 3rd space from the main thoroughfare in Row #9. Weather conditions were overcast with a slightly wet roadway from earlier precipitation. Vehicle 1 had moved prior to police arrival and Vehicle 2 maintained the position at point of impact until police arrival.

Driver 2 stated that she backed Vehicle 2 from its parking space with the rear of the vehicle angled to the left. After backing out of the space, Driver 2 placed Vehicle 2 in "Drive" and was subsequently struck by another vehicle backing from parking spaces across the way. Driver 2 advised that she had checked the area behind her vehicle prior to backing utilizing the mirrors as well as a rear-view camera in the dashboard. Driver 2 reported no injuries at the scene.

Driver 1 stated that she backed Vehicle 1 from its parking space with the rear of the vehicle angled to the left. Driver 1 stated that Vehicle 2 was struck by Vehicle 1 while backing. Driver 2 made no statements with respect to what gear Vehicle 1 was in at the time of the crash as well as utilizing mirrors or a rear-view camera. Driver 2 and her passenger reported no injuries at the scene.

Minor damage was observed to both vehicles and both were able to be driven away.
