145. Crash Description/Narrative

Vehicle 2 was attempting to make a left turn from Route 88 into the parking lot of At Home (1930 Route 88).

Vehicle 1 was passing Vehicle 2 on the right side shoulder when it side-swiped the vehicle. Vehicle 1 left the scene of the crash after striking Vehicle 2. The driver of Vehicle 2 provided dispatch with the license plate of Vehicle 1.

The driver of Vehicle 2 stated that she was attempting to make a left turn into the parking lot of At Home. While stopped, she stated that she saw Vehicle 1 moving around her vehicle in the shoulder. The driver side mirror of Vehicle 1 then scratched the passenger side of Vehicle 2 and struck the passenger side mirror. The driver of Vehicle 2 was not injured in the crash and her vehicle suffered minor damage.

Police units headed to the residence of the registered owner of Vehicle 1 and were able to locate the vehicle. Damage was noticed on the driver side mirror of Vehicle 1 with silver paint transfer, consistent with what was reported. The driver of Vehicle 1 originally stated that he was not involved in the crash. He later advised that he had been lying and was involved in the crash. He stated that while passing on the shoulder, Vehicle 2 moved over which caused him to strike the vehicle. The driver of Vehicle 1 was not injured in the crash and his

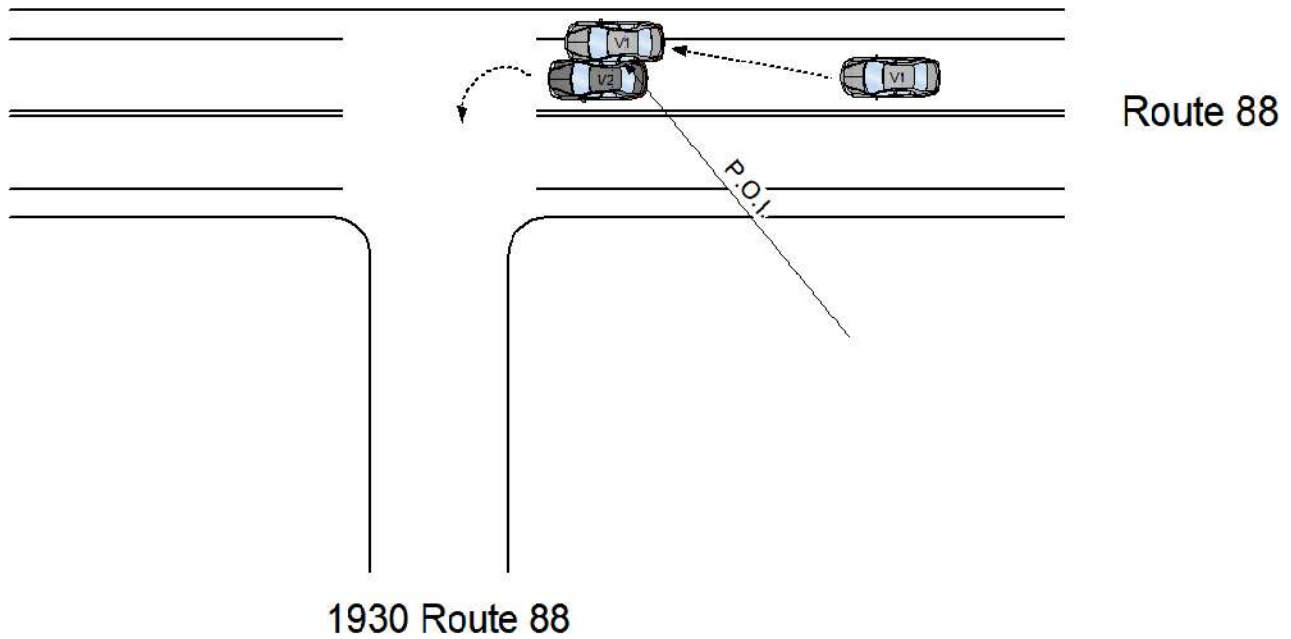
