145. Crash Description/Narrative

Vehicle #1 was parked in a marked parking space in front of Barons Bagels, located at 1743 Route 88. Vehicle #2 was driving in the aisle of the same parking lot.

Driver #1 stated she was attempting to back out of her parking spot and did not see any vehicles coming. She continued to look in her rear view camera as she continued to back up and still did not see Vehicle #2 driving. As she was backing out, Vehicle #2 hit the rear of her car.

Driver #2 stated she was driving through the parking lot from the side of the building. She continued around the front of the building and was passing all the parking spaces when Vehicle #1 backed up into the vehicle causing damage the passenger side quarter panel area of her vehicle.

Based on the statements made by both drivers and my observations on scene, I determined Vehicle #1 to be at fault for the crash.

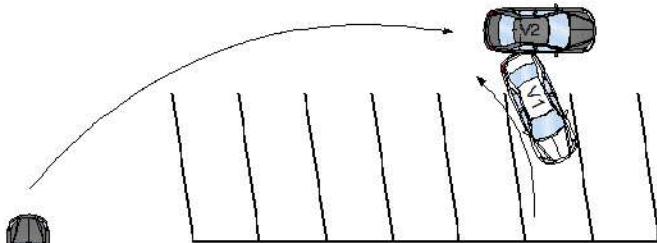
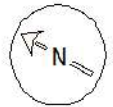
