145. Crash Description/Narrative

Vehicle #1 collided with Vehicle #2 in a right angle crash on Olden Street in the westbound lane.

The Driver of Vehicle #1 stated he was stopped at the stop sign at the exit of the Home Depot parking (Olden St exit) observing traffic. Driver #1 stated a vehicle in the right lane (witness) stopped and allowed him to exit the lot to travel westbound on Olden Street. Driver #1 stated he attempted to make a right turn onto Olden Street to enter the left lane. Driver #1 stated he needed to make a wide turn to make the right. Driver #1 stated as he was making the turn his vehicle was struck by Vehicle #2. The Driver of Vehicle #1 had a complaint of head and back pain and was transported to Ocean Medical Center. Vehicle #1 had front drivers side damage.

The Driver of Vehicle #2 stated she was traveling westbound on Olden street in the left lane when Vehicle #1 entered her lane of travel causing the crash. Vehicle #2 had passengers side front end damage as well as front and passengers side air bag deployment. Driver #1 had a complaint of pain in the shoulder, neck and head area and was transported to Ocean Medical Center. Vehicle #2 was ultimately towed by D and L towing.

A witness on scene advised they witnessed the crash and stated the following. The witness was traveling on Olden

near the Home Depot exit in the right lane. As traffic backed up by the exit she stopped to allow vehicle #1 to exit the parking lot. Vehicle #1 slowly exited the lot towards the left lane. At that time the crash occurred.

The witness stated the black SUV (Vehicle #2) appeared to be traveling at a high rate of speed.

After the Driver of Vehicle #1 was transported I spoke to his co-worker on scene who advised the front passenger is now complaining of jaw pain and he will be transporting him to the hospital.

It should be noted on arrival I observed the collision took place on Olden Street in the left lane and Vehicle #1 front tires were turned to the left as if it was making a left out of the lot.

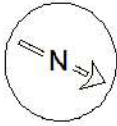

Motor Vehicle Crash Diagram

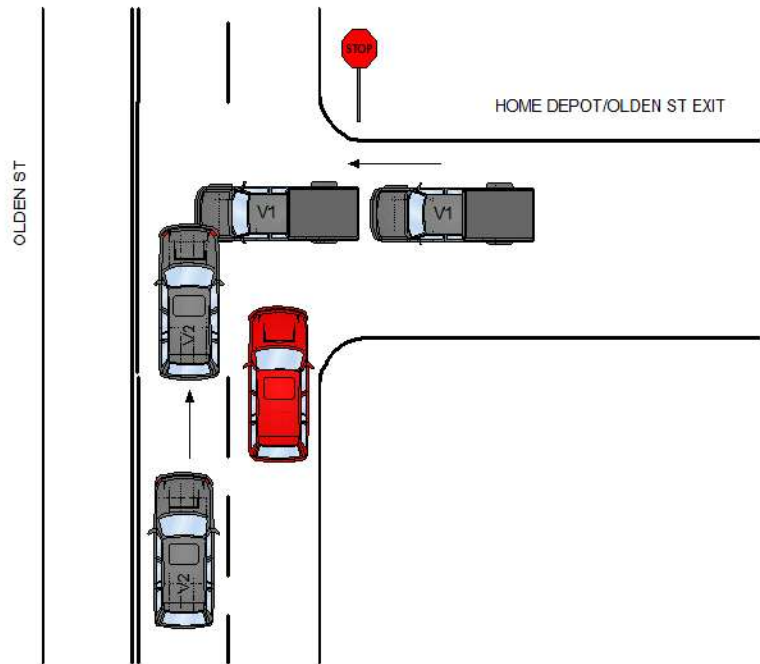
