145. Crash Description/Narrative Vehicle #1 was traveling West on Route 88. Vehicle #2 was traveling East on Route 88. Vehicle #2 attempted to make a left hand turn from Route 88 into the parking lot of Brandywine Living at Reflections (1594 Route 88). While attempting the turn vehicle #2 was struck by vehicle #1. The driver of vehicle #1 stated they were driving West on Route 88. While driving vehicle #2 made an abrupt left turn in front of him, in a attempt to enter the lot. The driver then attempted to brake to avoid the crash, but was unable to do so, thus striking the other vehicle. The driver of vehicle #2 stated through a translator. He was unfamiliar with the area. He was attempting to drop his friend off at the hospital, due to injury sustained the previous day. While making the turn he slowed his vehicle because he realized the parking lot he was turning into was not the hospital. At that time his vehicle was struck. All parties involved refused medical attention on scene.

BWC was activated during incident.

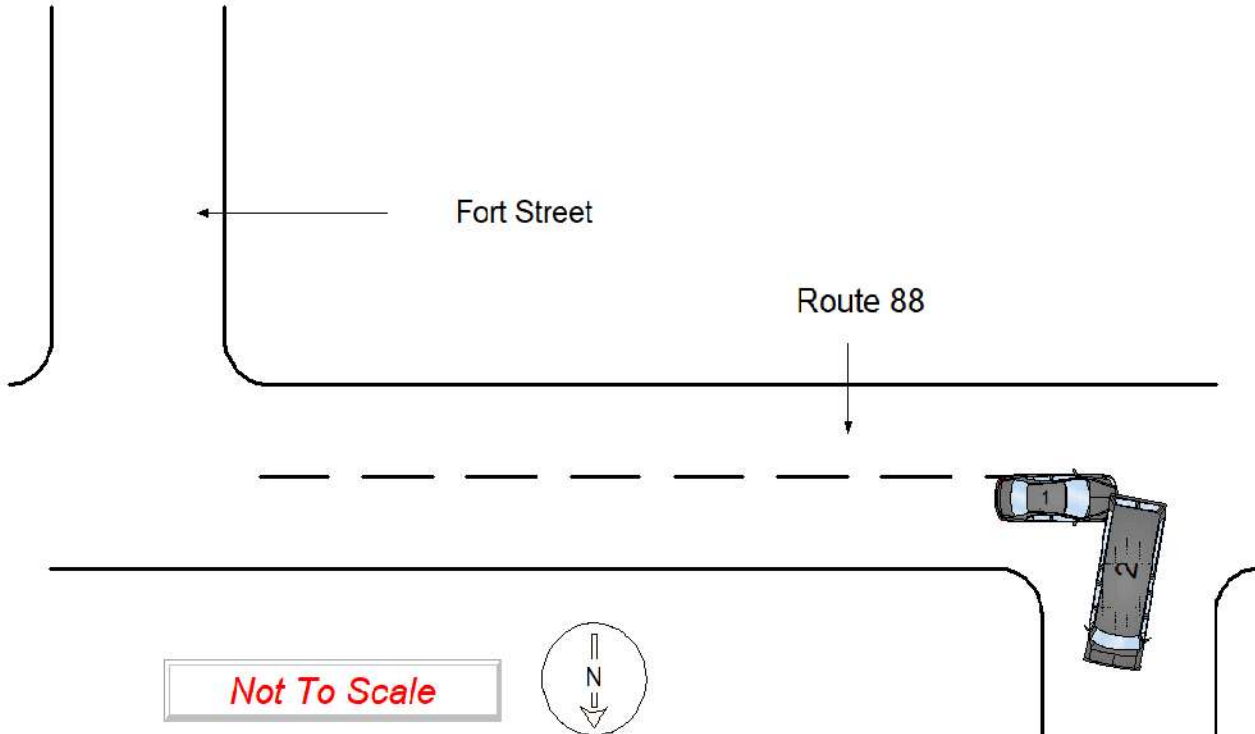
