145. Crash Description/Narrative

The crash occurred in the parking lot of WAWA located at 1902 RT 88.

Vehicle 1 was traveling east in the parking lot.

Pedestrian 1 was working in the parking lot.

Vehicle 1 failed to observe Pedestrian 1 resulting in the crash.

The driver of vehicle 1 stated, she was coming around the gas pump island, looking for an open pump. She stated

there were no cones in the area where pedestrian 1 was working and she did not see him, resulting in the crash.

I did not observe any damage to her vehicle, and she did not report any injuries on scene.

Pedestrian 1 stated he was working near the back of the parking lot, near RT 88, when he was struck from behind by

vehicle 1. He had a laceration to his right foot and knee. He was transported to OMC by Brick Twp EMS.

WAWA staff had a video of the incident, which showed vehicle 1 traveling east in the parking lot and Pedestrian 1

bent over cleaning up. Vehicle one hit an orange bucket and then strikes Pedestrian 1 from behind. WAWA was

unable to provide a copy of the video at this time.

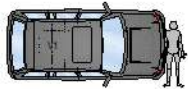
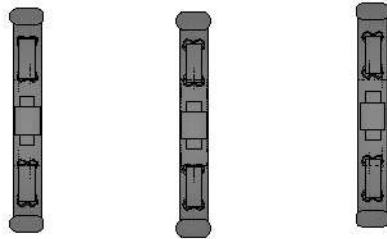
