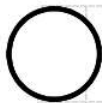

145. Crash Description/Narrative

Vehicle #1 collided with Vehicle #2 in a right angle crash on RT 88 in the westbound lane near the exit of Wawa (1902 RT 88).

The Driver of Vehicle #1 stated prior to the crash she was stopped at the stop sign at the exit of Wawa. Driver #1 stated she was attempting to make a left on to RT 88 eastbound. Driver #1 stated while observing traffic. Vehicle #2 came to a complete stop in the westbound lane and waved to her to allow her to exit the lot. Driver #1 advised after eastbound traffic passed, she attempted to make the left turn out of the lot. However at that time Vehicle #2 began to travel straight ahead. As a result the front end of her vehicle struck the middle of the passengers side of Vehicle #2. Vehicle #1 had minor front end damage.

The Driver of Vehicle #2 stated she came to a complete stop on RT 88 westbound to allow Vehicle #1 out of the parking lot. However, shortly after she realized Vehicle #1 was making a left and she did not believe Vehicle #1 was going to be able to make the left for some time. At which time she continued westbound on RT 88 before Vehicle #1 struck her vehicle along the middle of the passengers side. Vehicle #2 had moderate passengers side damage.

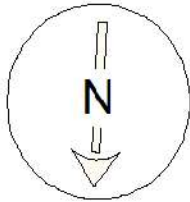

Motor Vehicle Crash Diagram

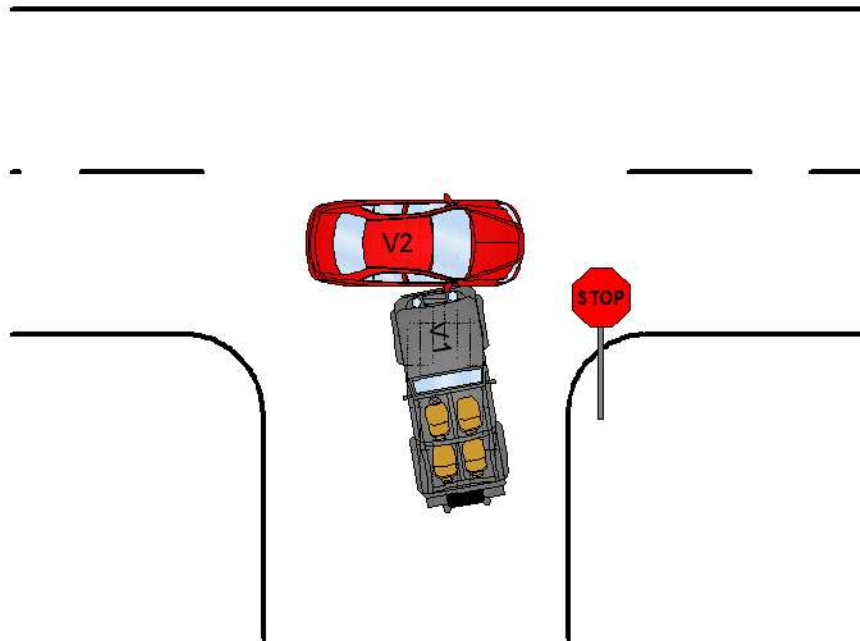
