145. Crash Description/Narrative

Crash diagram reveals a two car same direction rear-end. Vehicle 1 (V1) was directly behind Vehicle 2 (V2) traveling eastbound on State Highway 88 approximately 10 feet west from Coolidge Drive.

The driver of V1 stated when the light turned green, V2 began to accelerate and put his left blinker on to turn onto Coolidge Dr. The driver of V1 then crashed into the rear of V2 when V2 was slowing down to make the turn.

The driver of V2 stated he was traveling eastbound on State Highway 88 when he was slowing down to turn left onto Coolidge Dr. Before turning, V1 crashed into the rear of his vehicle.

Both cars were pulled off into a parking lot and there were no injuries reported on scene.

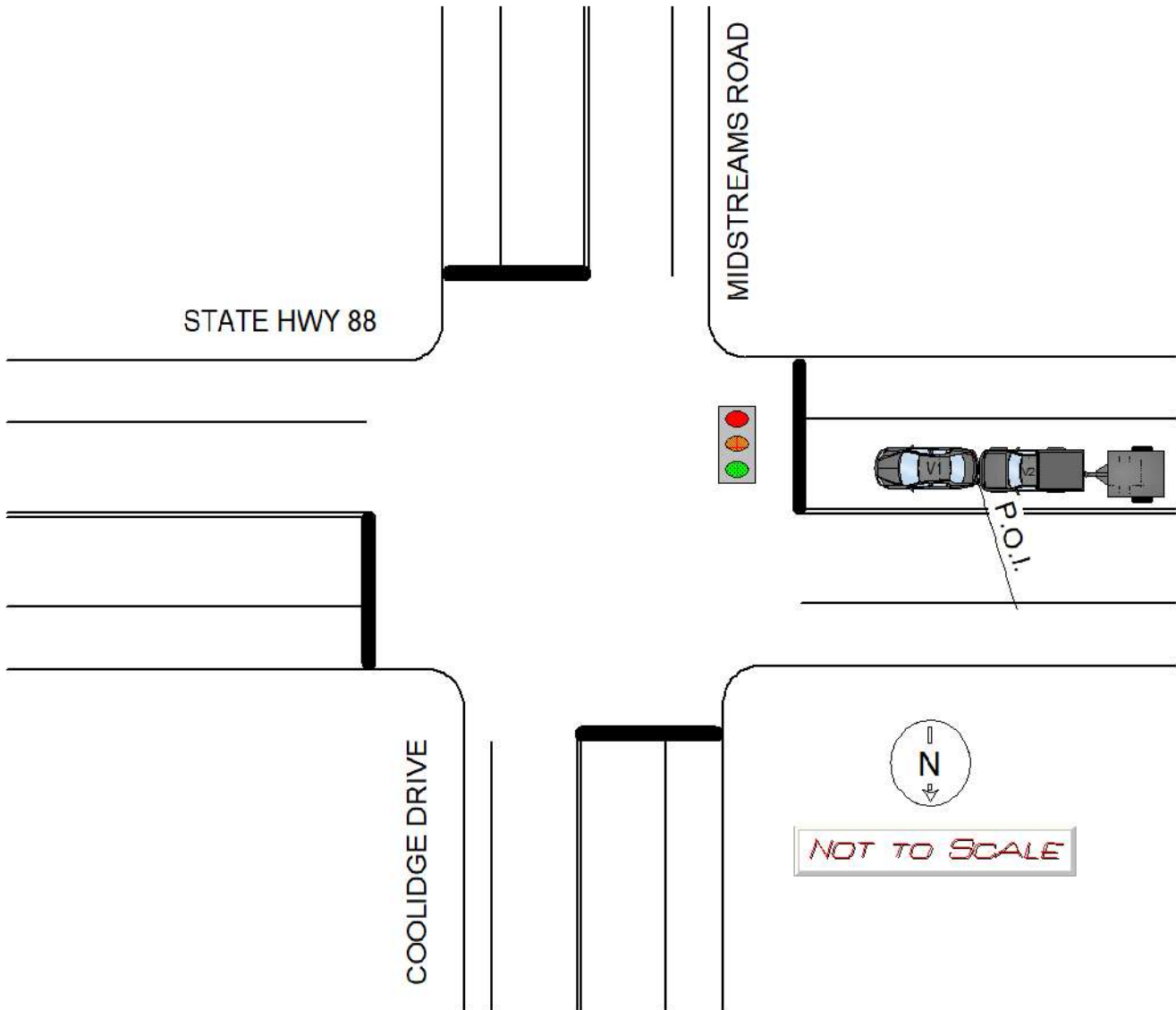
