The front bumper was cracked in several places as well as the front license plate being ripped off of the vehicle.

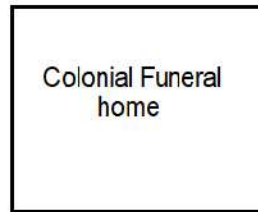
Vehicle 1 had a large amount of deer hair on the front bumper. Based on my investigation, Driver 1 is not at fault for the accident.

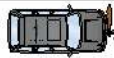
