145. Crash Description/Narrative

Vehicle 01 was traveling North on NJ-88. Vehicle 01 ran off the road to the right striking JCP&L Pole #JC141BK.

The operator of Vehicle 01 advised the following information. While traveling North on NJ-88, he observed a vehicle of an unknown make or model pull out in front of him from the parking lot of 1520 NJ-88. In an attempt to avoid the collision with the unknown vehicle, he swerved to the right. While doing so, he struck a utility pole.

Based on observations and statements made on scene, Vehicle 01 was determined to be a fault. JCP&L was notified and advised they were responding due to the heavy damage to the utility pole.

Department-issued BWC was activated for the duration of this investigation.
