145. Crash Description/Narrative

V1 driver stated she was traveling westbound, in the center lane, on Rt. 70 approaching Jack Martin Blvd. V1 driver further stated that she realized too late that she needed to make a right-hand turn onto Jack Martin Blvd and quickly crossed over the right lane, inattentive to oncoming traffic, and struck V2. When V1 struck V2, V1 continued into the right-hand turn, furthering damage to the left-side of V2.

V2 driver stated she was traveling westbound, in the right lane, on Rt. 70 approaching Jack Martin Blvd. V2 driver stated that as she was going to make the right-hand turn onto Jack Martin Blvd, V1 crossed over from the center lane into the right lane, striking V2. V2 driver stated V1 continued into the right-hand turn causing more damage to the left side of the vehicle.

It was determined that V1 conducted an improper lane change from the center lane to the right lane, in order to make a right-hand turn onto Jack Martin Blvd. This resulted in V1 striking V2.

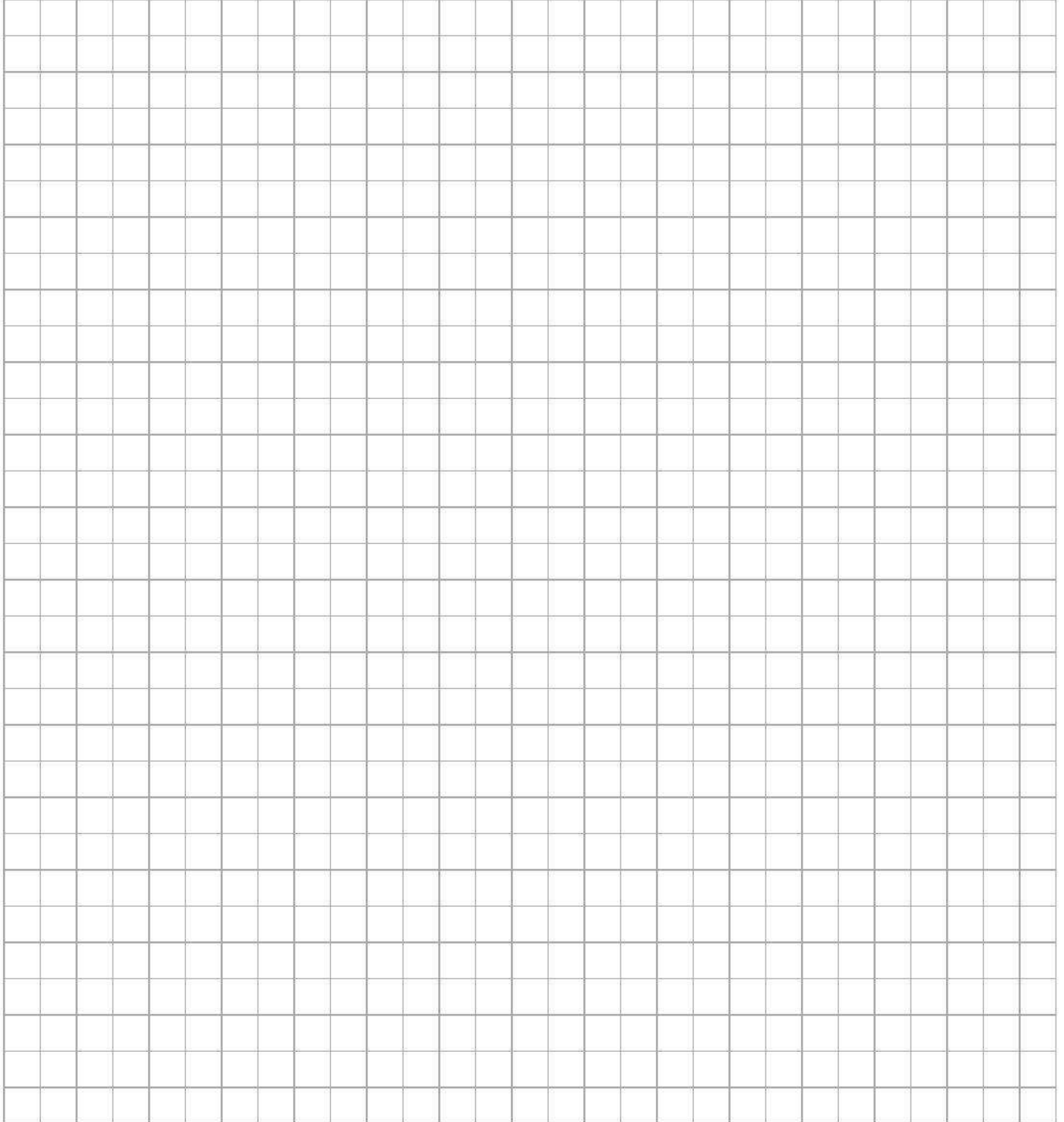
V2 driver had complain of pain to her chest area from hitting the steering wheel during the strike of the vehicle.
