145. Crash Description/Narrative

A motor vehicle collision occurred on Van Zile Road south bound approximately 175 feet north bound of the intersection with Route 70. Vehicle 02 was traveling straight ahead in the right travel lane of Van Zile Road south bound approaching Route 70. Vehicle 01 was negotiating the off ramp of Route 70 west bound onto Van Zile Road Road, failed to stop at the stop sign, and the front driver side corner of vehicle 01 struck the passenger side middle of vehicle 02.

While on scene, driver 01 reported a minor bleeding cut to her ride hand. Driver 02 reported complaints of pain to his neck and back. Brick Township Emergency Medical Services responded on scene and both parties refused medical attention.

Driver 01 stated she was traveling on Route 70 west bound and entered the ramp to get onto Van Zile Road. Driver 01 said she approached Van Zile Road and began to enter the roadway when vehicle 02 suddenly appeared in front of her causing the collision. Driver 01 explained she did not observe the stop signs posted at the end of the ramp prior to Van Zile Road until I pointed them out.

145 Crash Description

Driver 02 stated he was traveling on Van Zile Road south bound headed towards Route 70. Driver 02 explained he was in the right travel lane and twisted his body to grab something from his right side. Driver 02 said he observed vehicle 01 travel down the ramp towards him as he was about to pass in front of her when she failed to stop at the stop sign causing the motor vehicle collision.

Through my investigation, I find driver 01 at fault for failure to obey stop sign and for failure to yield right-of-way. Driver 01 was issued traffic summons: 1506 T 167266 in violation of 39:4-97.

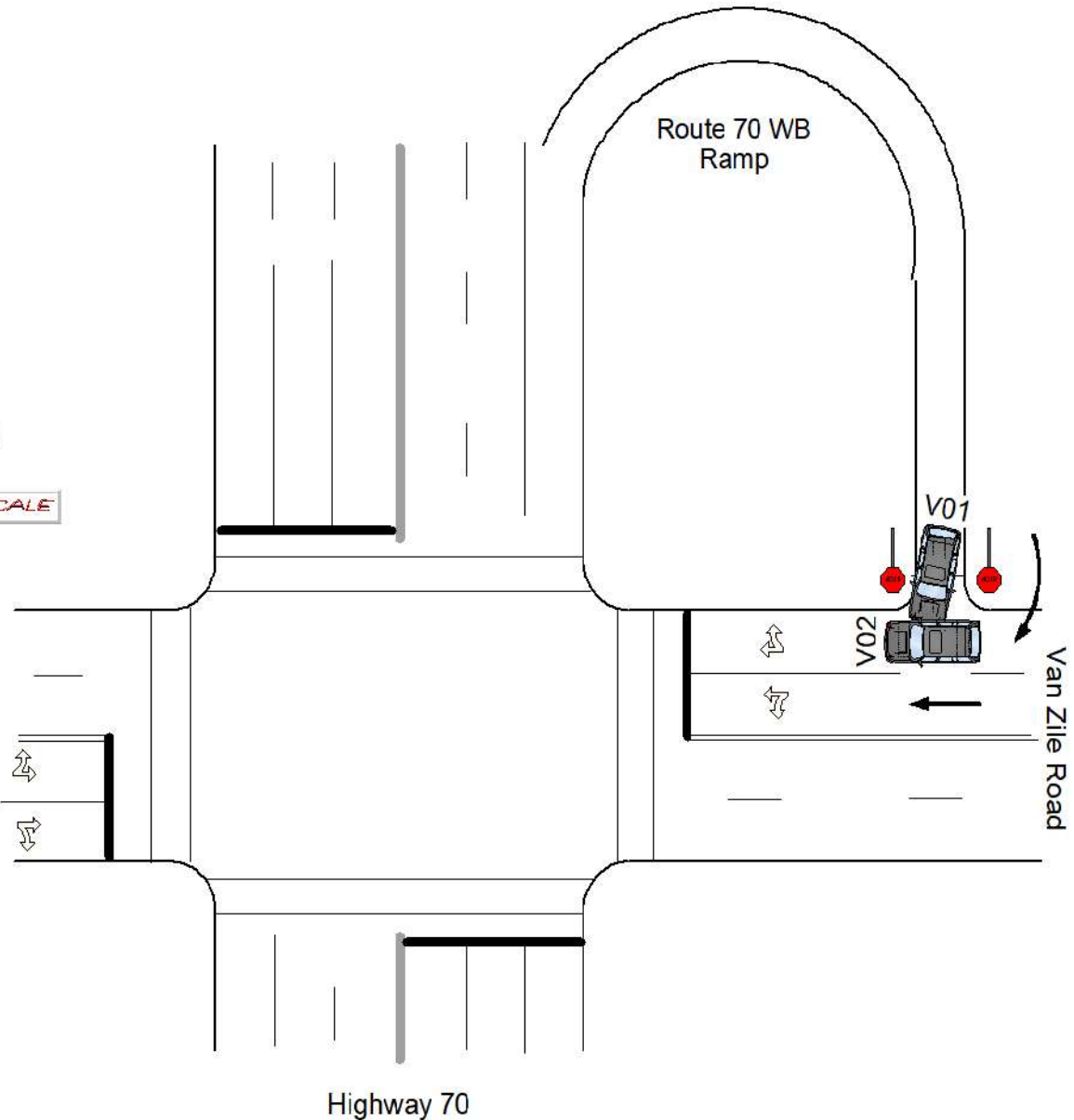
