145. Crash Description/Narrative

Two vehicle crash occurred on 8/16/2022 at approximately 0857 hours on Route 88 near the intersection with Hoffman St. My body worn camera was on during this investigation. Ptl. Byslma #328 arrived on scene to assist.

Driver of vehicle #1 advised she was traveling westbound on Route 88 and attempted to make a left into her doctor's office at 1673 Route 88. Driver of vehicle #1 stated she struck vehicle #2 in the front with the front of her vehicle as she attempted to make the left turn.

Driver of vehicle #2 advised she was traveling eastbound on Route 88 and vehicle #1 made a sudden left turn in front of her. Driver of vehicle #2 advised she was struck in the front by the front of vehicle #1.

Driver of vehicle #2 had a complaint of pain in her right wrist. Brick Police EMS arrived on scene and stated driver of vehicle #2 had some disfiguration in her wrist indicating possible fracture. Driver of vehicle #2 was transported to Brick Hospital for further evaluation.

Driver of vehicle #1 is found to be at fault for the crash and was issued summons #E22003750 for careless

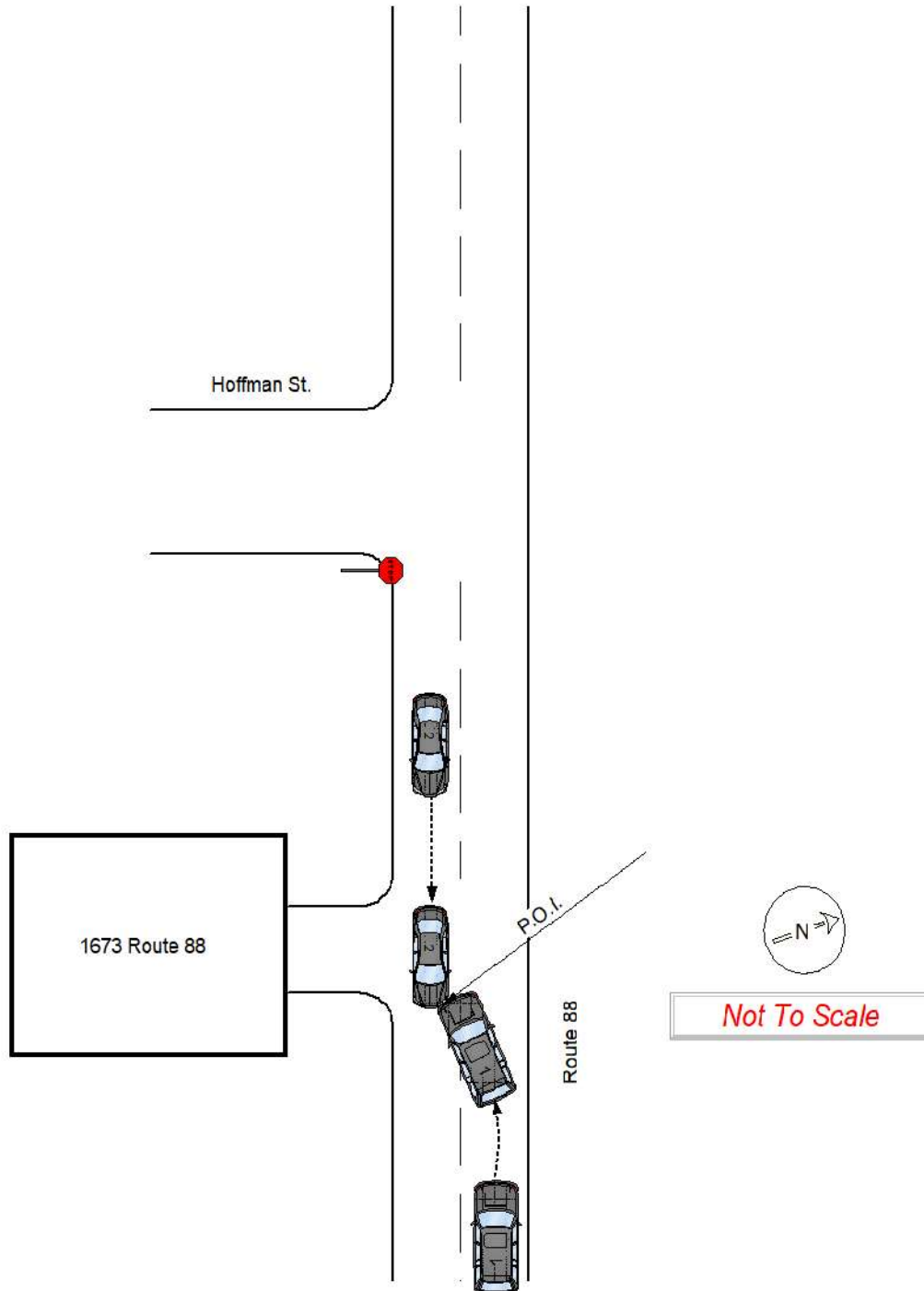
