145. Crash Description/Narrative

A motor vehicle collision occurred in the intersection of Route 88 and Burrsville Road. Vehicle 02 was traveling straight ahead on Route 88 headed east bound. Vehicle 01 was traveling south bound on Burrsville Road and came to a stop at the stop sign located just before the intersection with Route 88. Vehicle 01 made a left turn onto Route 88 east bound just as vehicle 02 was about to pass causing the rear driver side corner of vehicle 01 to strike the front driver corner of vehicle 02.

While on scene, there were no reported injuries and all parties declined medical attention.

Driver 01 stated she came to a stop at the stop sign on Burrsville Road and waited to make a left turn on Route 88. Driver 01 said she misjudged the distance between vehicle 01 and vehicle 02 and made her turn at the wrong time causing the collision.

Driver 02 stated she was traveling straight ahead on Route 88 west bound. Driver 02 said she observed vehicle 01 make a sudden turn ahead of her just as she was about to pass causing vehicle 01 to side swipe vehicle 02.

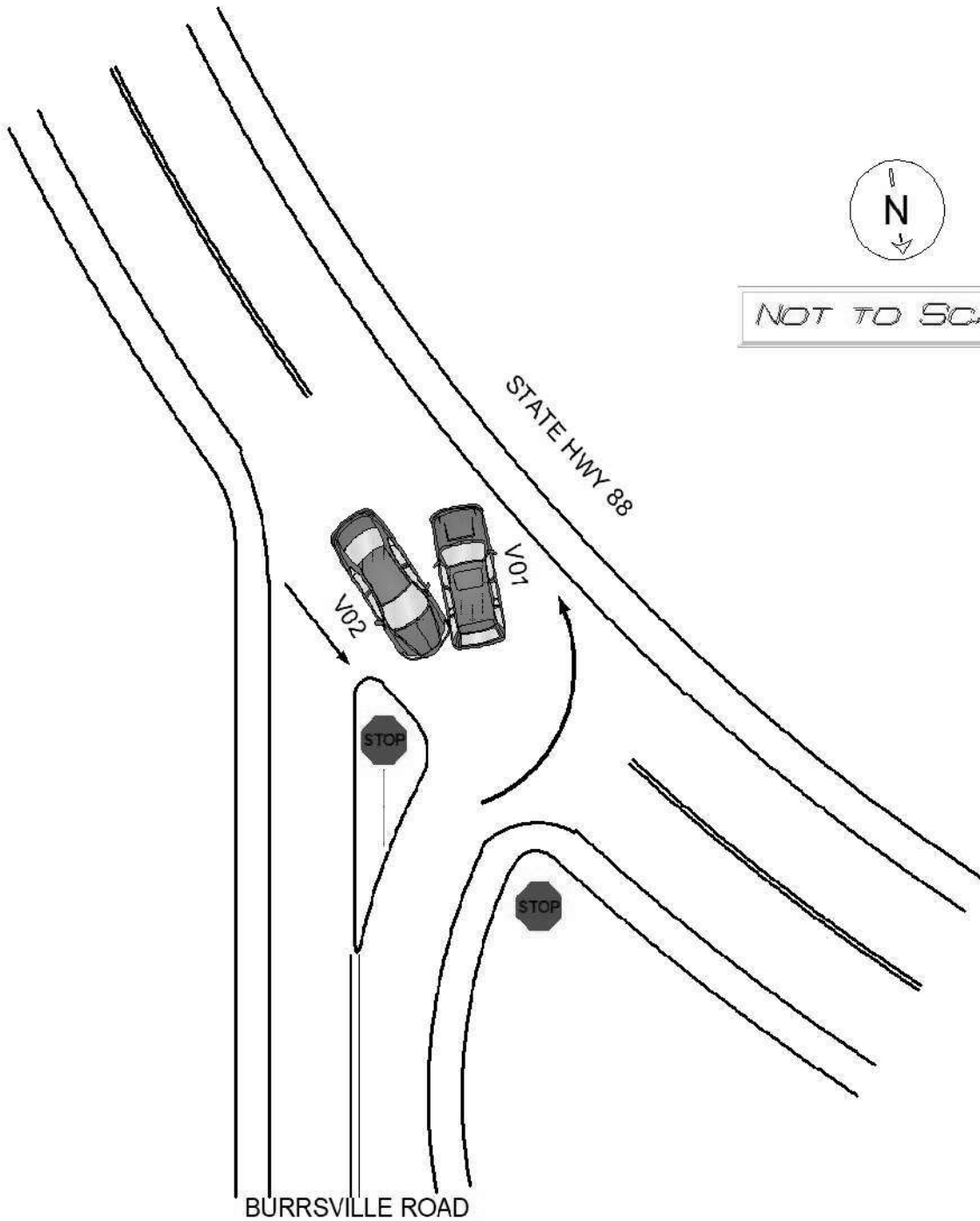
