145. Crash Description/Narrative

Vehicle #2 was traveling on Jack Martin Blvd southbound, near 475 Jack Martin Blvd. Vehicle #1 was making a left turn out of the parking lot of 475 Jack Martin Blvd. Vehicle #1's front bumper struck the right front fender of vehicle #2.

Driver of vehicle #2 stated she was traveling on Jack Martin Blvd southbound, near 475 Jack Martin Blvd. She observed a pickup truck make a right turn out of the parking lot of 495 Jack Martin Blvd. The pickup truck then pulled off to the shoulder of the road and the driver started waving their arm. She thought the driver was waving her on, telling her to pass them. As she continued to travel on Jack Martin Blvd southbound, the stopped pickup truck blocked her view of vehicle #1, attempting to pull out of 475 Jack Martin Blvd. When the pickup truck was no longer blocking her view, vehicle #1's front bumper struck her right front fender.

Driver of vehicle #1 stated she was pulling out of the parking lot of 475 Jack Martin Blvd, attempting to make a left turn onto Jack Martin Blvd northbound. She saw the pickup truck make a right turn out of the parking lot of 495 Jack Martin Blvd. She did not see vehicle #2 as she pulled out into the roadway. At that time, her front bumper struck the right front bumper of vehicle #2. She had just checked for any vehicles traveling in the

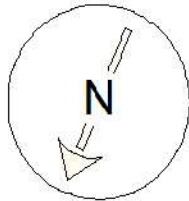

Motor Vehicle Crash Diagram

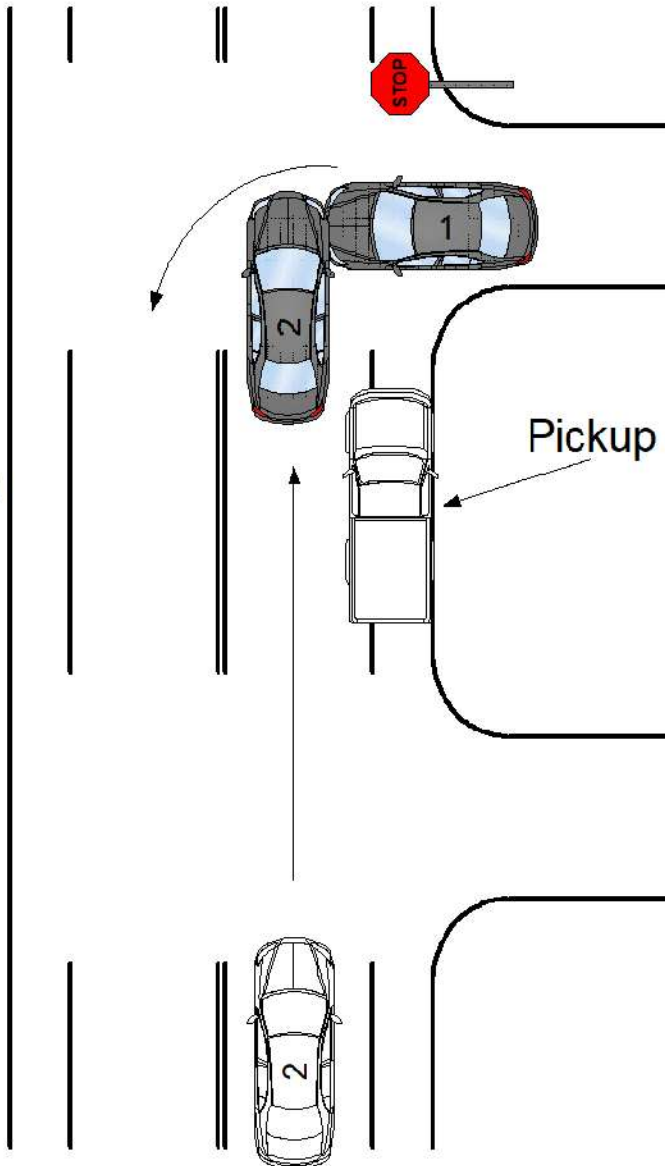
