145. Crash Description/Narrative

In the parking lot of 495 Jack Martin Blvd Vehicle 01 was traveling south making a left into a parking space when struck Vehicle 02 parked to the right.

Driver of Vehicle 01 stated he was driving south making a left into a parking spot and didn't know he struck parked Vehicle 02 to his right. Driver of Vehicle 01 showed me fresh minor scratches to the right front of his vehicle.

The owner of Vehicle 02 stated she was sitting in her vehicle parked facing forward when Vehicle 01 pulled into the parking space to her left striking Vehicle 02's left rear bumper causing minor scratches.
