145. Crash Description/Narrative

Two vehicle crash occurred in the parking lot near the grocery entrance of Walmart (1872 Route 88) on 8/5/2022 at approximately 1126 hours. My body worn camera was on during this investigation.

Driver of vehicle #1 advised she was backing out of a marked parking space and another car approaching in the travel lane distracted her and blocked her sight of vehicle #2. Driver of vehicle #1 stated she struck vehicle #2 in the rear with the rear of her vehicle. Driver of vehicle #1 advised there was no damage to her vehicle.

Driver of vehicle #2 was in a marked parking space waiting for a grocery delivery with the vehicle running and in park. Driver of vehicle #2 advised as he was sitting, waiting, he was struck from behind by vehicle #1.

I observed no discernable damage to vehicle #1 and minor damage to the rear bumper of vehicle #2.

Driver of vehicle #1 is at fault for backing unsafely and driver inattention.

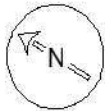

Motor Vehicle Crash Diagram

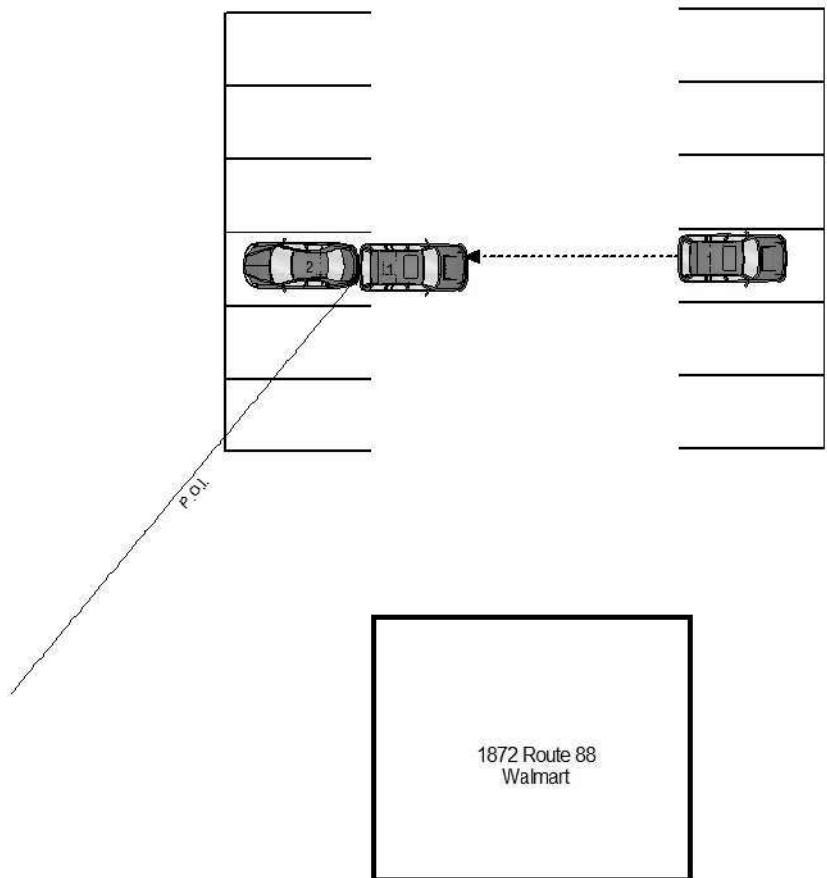
