145. Crash Description/Narrative

Vehicle #2 was traveling in the westbound lane of Rt. 88 attempting to turn into WAWA (1902 Rt. 88). Vehicle #1 attempted to pass Vehicle #2 on the left and side swiped the left side of Vehicle #2. Vehicle #1 then fled the scene and turned right onto Jack Martin Blvd.

Driver #2 stated that he was attempting to turn right into the WAWA when a newer model gray Dodge Ram side swiped the left side of his vehicle as it was trying to pass. After being struck by Vehicle #1, it continued west on Rt. 88 and turned onto Jack Martin Blvd.

After my investigation I have determined that Vehicle #1 is at fault for the incident.

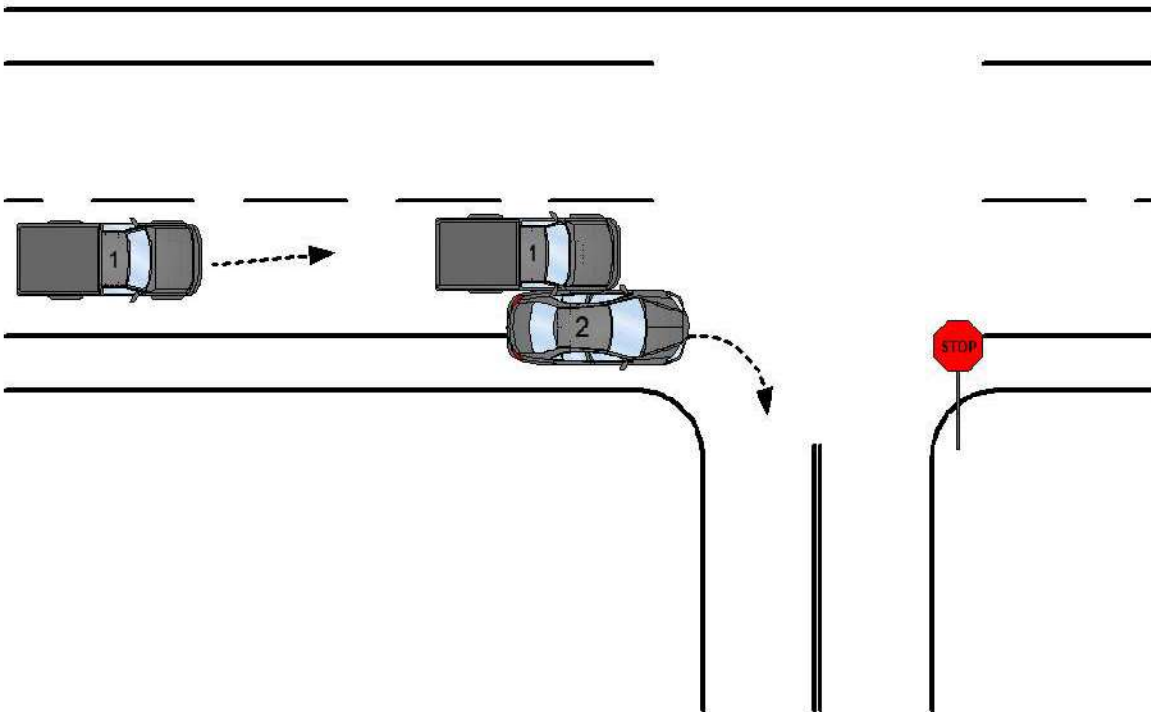
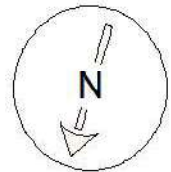
