145. Crash Description/Narrative

Vehicle 01 was backing out of her parking space (Walmart) when she struck the right side of Vehicle 02.

Driver 01 stated she was backing out of her parking space and did not see Vehicle 02. Driver 01 stated she hit the side of Vehicle 02 with the rear of her vehicle.

Driver 02 stated she was waiting in traffic to turn into a parking space, when Vehicle 01 struck the right side of her vehicle.

No parties were injured and all refused medical attention.

Vehicle 01 had minor damage to its rear bumper and was able to be driven from the scene. Vehicle 02 also had minor damage to its front and rear passenger door's and was able to be driven from the scene.

Upon conclusion of my investigation, I found Driver 01 to be at fault. Due to Driver 1's unsafe backing and inattention to the road she did not see Vehicle 02, thus colliding with the side of it.

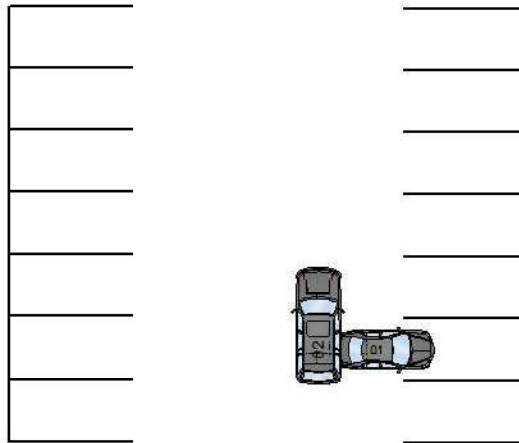
