145. Crash Description/Narrative

Crash investigation revealed that two vehicles struck as they were backing out from parking spots at 1902 Route 88 (Wawa). No injuries were reported on scene and both vehicles has minor damage.

Driver of vehicle 1 stated that she did not see vehicle 2 and began to back out of her parking spot. Vehicle 1 then struck vehicle 2 which was directly behind it.

Driver of vehicle 2 stated that she had just completed backing up and was about to put her car in drive when she felt her car get hit.

I was able to watch the surveillance video from the store of the crash.

Video showed that Vehicle 2 was illegally parked in a marked fire lane and backed out from the area. Once Vehicle 2 was backed fully out of the fire lane and about to shift from reverse into drive, Vehicle 1 then backed out directly into Vehicle 2. Even though Vehicle 2 had been illegally parked initially, I find the actions of the driver of Vehicle 1 at fault for this crash. The driver of Vehicle 1 failed to look behind her vehicle to ensure

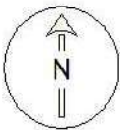

144 Crash Diagram (NOT TO SCALE)

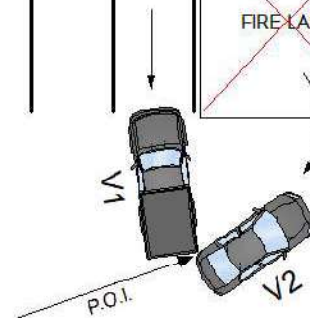
