145. Crash Description/Narrative

Vehicle #1 was traveling westbound on Route 88, in the area of Younger Street.

Driver #1 stated he had just passed Younger Street when a deer that was off to the right side of the road in the grass ran into the roadway and into the side of his car. Driver #1 stated the deer laid in the roadway for a few seconds before getting up and running into the wooded area on the south side of Route 88. There was an imprint of a deer's head in the dew of Vehicle #1 in the passenger side rear window, along with pieces of fur in the rear passenger side door handle. I observed two small dents in the passenger side quarter panel that Driver #1 stated was new damage.

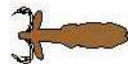
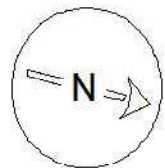
