145. Crash Description/Narrative

Vehicle #2 was traveling on Route 70 eastbound, near the intersection of Jack Martin Blvd. Vehicle #1 was traveling on Route 70 eastbound, near the intersection of Jack Martin Blvd. Vehicle #2 and vehicle #1 side swiped each other in the center lane.

Driver of vehicle #2 stated he was traveling in the center lane of Route 70 eastbound, near the intersection of Jack Martin Blvd. Vehicle #1 was traveling in the right lane and changed into his lane. Driver of vehicle #1 stated she was traveling in the center lane of Route 70 eastbound, near the intersection of Jack Martin Blvd. Vehicle #2 was traveling in the left lane and changed into her lane. At that time, vehicle #2's right front bumper struck her left front bumper. She drove into the Walmart parking lot to exchange information. The driver of vehicle #2 stated he was trying to get into her lane. He would not talk to her when she tried to exchange information. Do to personal reasons she could not wait for the police and had to leave the

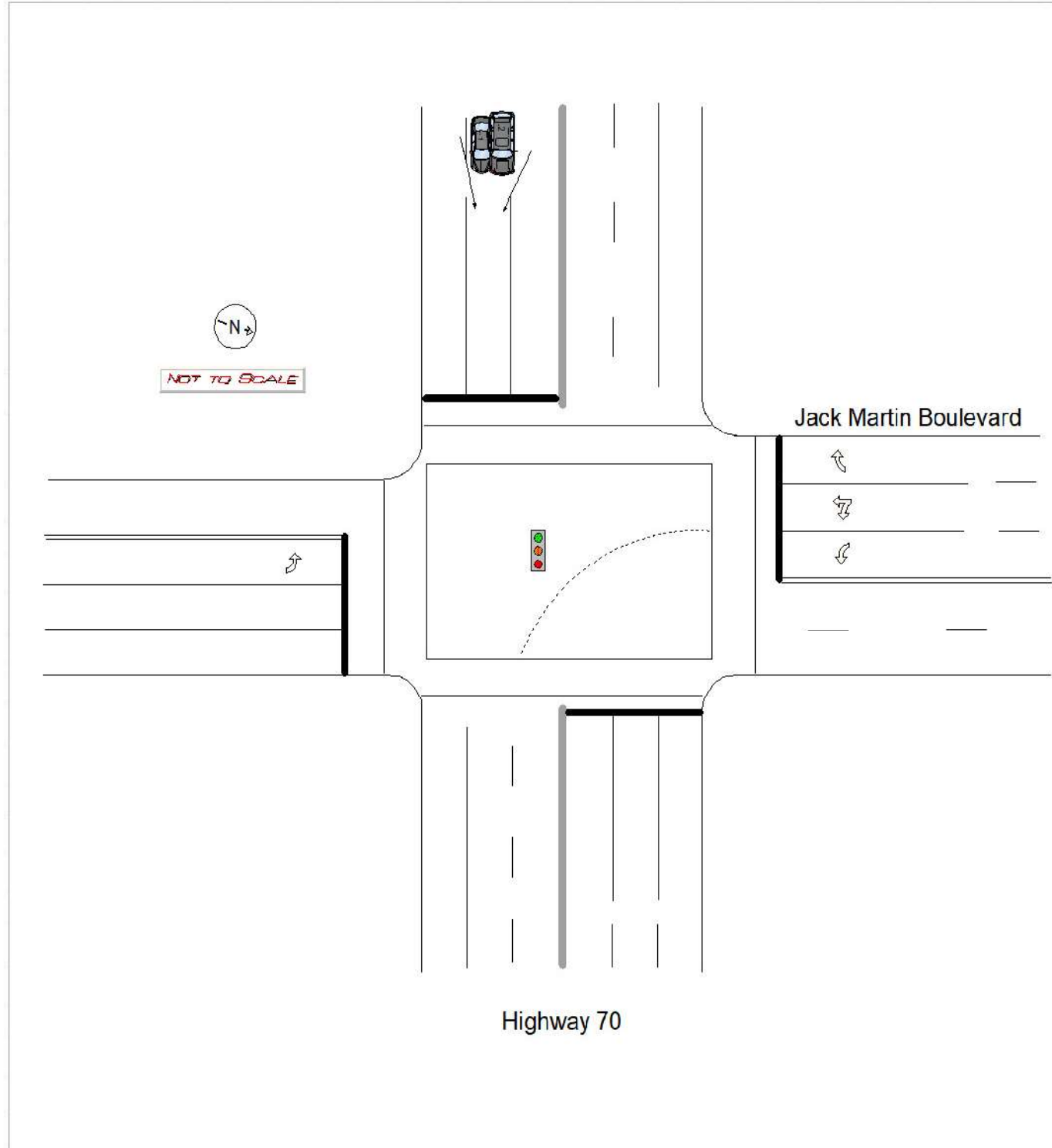
