145. Crash Description/Narrative

V1 was in the parking lot of 495 Jack Martin Blvd. D1 was attempting to pull into a parking space, when she attempted to apply the brake, she couldn't reach it and continued over the curb. V1 continued across the side walk and struck the corner of the building, closest to the Seashore Surgical Institute.

Brick PD EMS Unit M532 responded to the scene and D1 refused any medical assistance/assessment.

The damage to the building appeared to be relatively minor in nature and did not necessitate the FD or the Building Inspector to respond.

Building Manager Nancy Smith was notified of the MVC.

As a result of my investigation, I found V1 at fault for the MVC.

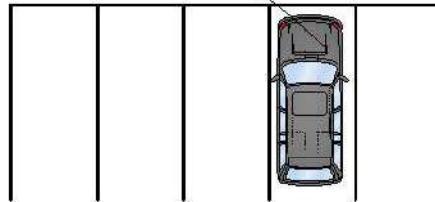
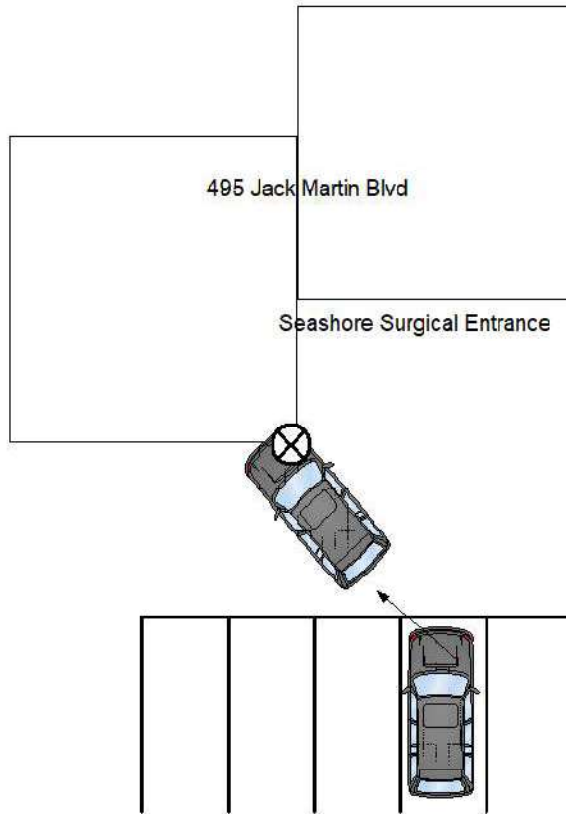

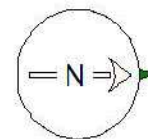
