145. Crash Description/Narrative

Vehicle 1 was traveling east on Route 88. Vehicle 2 was exiting the parking lot of 1617 Route 88 to enter the road way for Route 88. Vehicle 2 did not yield to Vehicle 1's right of way causing Vehicle 1 to impact Vehicle 2.

Driver 1 stated he was traveling east on Route 88 when Vehicle 2 pulled out in front of him.

Driver 2 stated he was waiting to pull out of the parking lot for 1617 Route 88. Driver 2 stated he thought he was clear to exit the lot before he began pulling out. Driver 2 advised when he saw Vehicle 1 it was too late and the Vehicles impacted.

My investigation revealed Vehicle 2 is at fault for the crash. Driver 1 had the right of way and there was no possible action Driver 1 could have taken to avoid the impact.

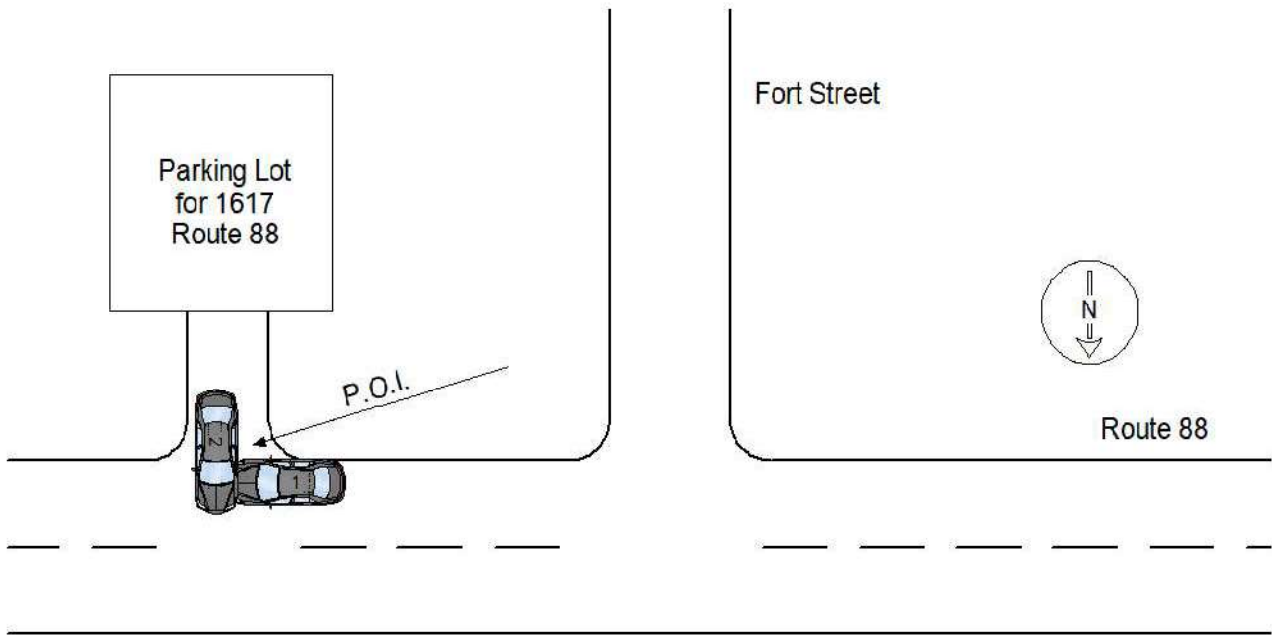
