145. Crash Description/Narrative

Vehicle 1 was traveling on east on RT 70 approaching the intersection of RT 70 and Olden Street. The front of

Vehicle 1 stuck the right lower rear of Vehicle 2, Vehicle 3, and Vehicle 4, causing disabling damage to all

vehicles.

The driver of Vehicle 2 stated that he was stopped at the intersection of RT 70 and Olden Street directly behind

vehicle 3. The driver of Vehicle 2 stated that the front of Vehicle 1 struck the right lower rear of Vehicle 2

causing Vehicle 2 to be pushed into the concrete median.

The driver of Vehicle 3 stated that he was stopped at the intersection of RT 70 and Olden Street directly behind

vehicle 4. The driver of Vehicle 3 explained that he heard a crash behind him and then felt the impact of Vehicle

1 striking the right lower rear of his vehicle.

The driver of Vehicle 4 stated that she was stopped at the intersection of RT 70 and Olden Street. The driver of

Vehicle 4 stated that she was the first vehicle in the lane with no other vehicles in front of her. The driver of

Vehicle 4 stated that a vehicle struck the rear of Vehicle 4 but that she was not sure which vehicle it was.
