145. Crash Description/Narrative

On 09/29/2022 at 0827 hours Ptl Giambona #290 and I, Ptl. Van Note #326, responded to NJ-88/ Olden Street for a motor vehicle accident report. Upon my arrival, I spoke with both drivers.

Driver 1 was traveling west on NJ-88 when she approached the intersection of NJ-88/ Olden Street with a green traffic signal. Driver 1 then made a left-hand turn onto Olden Street when vehicle 1 struck the left middle of vehicle 2. Driver 1 stated she did not see vehicle 2 due to one or two vehicles going straight ahead. Driver 1 stated vehicle 2 used the right hand lane to move around the vehicles which is permitted. Due to vehicle 2 moving around the vehicle(s), it was hidden and driver 1 did not see it.

Driver 2 was traveling eastbound on NJ-88 at the intersection with Olden Street. At the intersection, driver 2 stated she moved around a vehicle that was making a left turn onto Olden Street. When driver 2 approached the intersection and drove through it, this is when the front left fender of vehicle 1 struck the left middle of vehicle 2.

Ptl. Giambona supplied both drivers with instructions on how to retrieve their reports.

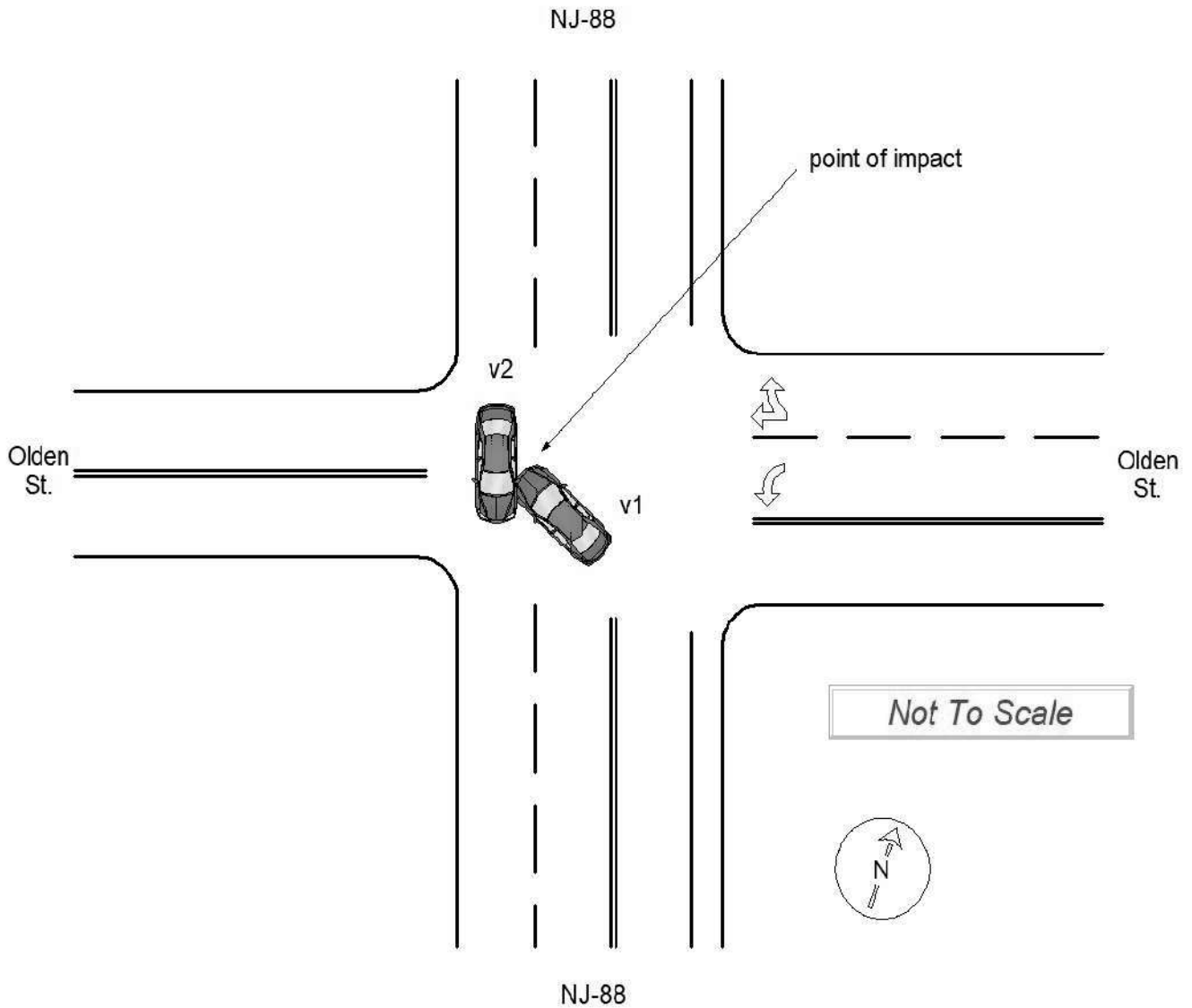
