145. Crash Description/Narrative

Vehicle 1 was traveling from the parking lot of Performance systems Integration and making a left onto Route 88 heading west. Vehicle 2 was traveling on Route 88 heading west. Vehicle 1 started to make a left hand turn and Vehicle 2 could not stop in time.

In speaking with the driver of Vehicle 1, he stated he was making a left hand turn onto Route 88. He stated the traffic was backed up and one of the drivers who was driving Route 88 east stopped to let him make the left hand turn. As he was inching out, he thought the road way was clear and started to make the turn onto Route 88 west bound. As he was making the turn he was struck by Vehicle 2. Driver 1 stated he thought driver 2 was speeding. The driver of Vehicle 1 also showed me video showing what had occurred. It corroborated his side of the story but I could not tell if Vehicle 2 was speeding or not.

In speaking with the driver of Vehicle 2, he stated he was driving west on Route 88. As he was approaching the intersection of Folsom Drive, he saw Vehicle 1 pulling into his lane attempting to make a turn. Driver 2 stated he slammed on his brakes in an attempt to stop but was not able to. I observed skid marks in the area where Vehicle 2 attempted to stop his vehicle.

145 Crash Description

Vehicle 1 had disabling damage to the front passenger side wheel well and the vehicle was left at the scene in the parking lot of Performance Systems Integration. Driver 1 had minor complaint of pain to his head but refused medical attention. Vehicle 2 had disabling damage to the front bumper on the drivers side. Driver 2 had minor complaint of pain to his lower back but refused any medical attention on scene. Vehicle 2 was towed by Andrews Auto Body but the vehicle was dropped off at the request of Driver 2 at a local body shop.

Based on the statements made and the facts of my investigation, Driver 1 is at fault for the accident due to Vehicle 2 having the right of away.

My BWC was activated for this incident.

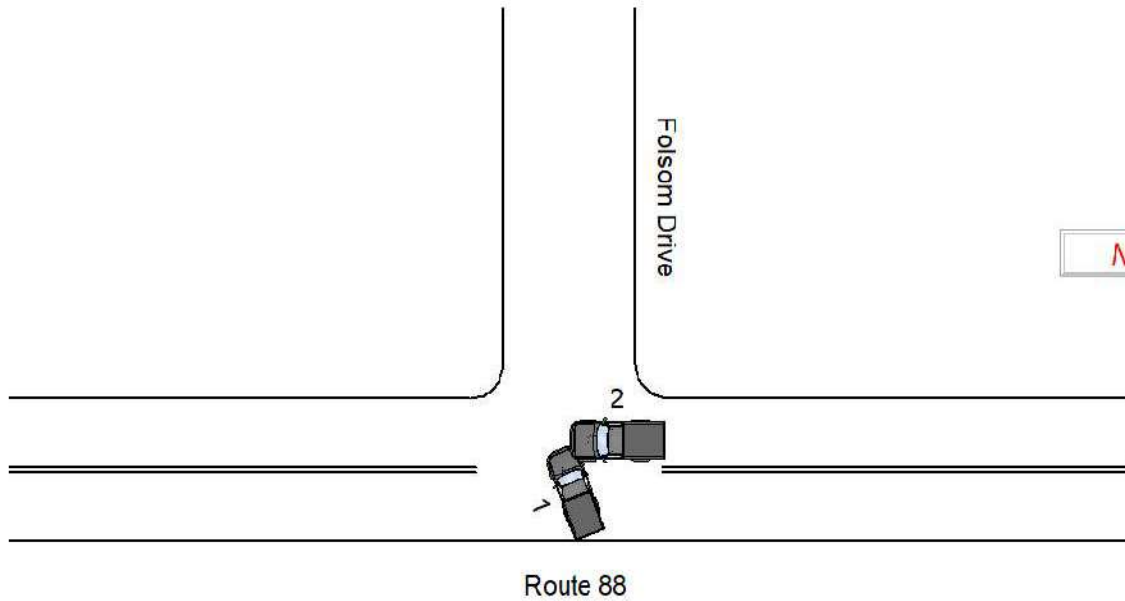
