145. Crash Description/Narrative

Vehicle 1 was traveling south on Jack Martin Boulevard in the left hand lane approaching Route 88. Vehicle 2 was directly in front of Vehicle 1. Vehicle 1 did not stop in time and struck the rear of vehicle 2.

In speaking with the driver of Vehicle 1, he stated that he was in the left lane directly behind Vehicle 2. As Vehicle 2 started to move forward, he started to move forward. Driver 1 saw Vehicle 2 start to slow down and thought he slowed down enough but did not. Vehicle 1 struck the rear of Vehicle 2 causing very minor damage to the front of Vehicle 1's license plate.

In speaking with the driver of Vehicle 2, she stated that she was sitting in traffic on Jack Martin Boulevard in the left hand lane. Driver 2 stated she was stopped in traffic when Vehicle 1 truck her from behind causing minor damage to the rear bumper of her vehicle.

Based on the statements made and the facts of my investigation, Driver 1 is at fault for the accident and was issued the following summons due to being arrest for DUI:

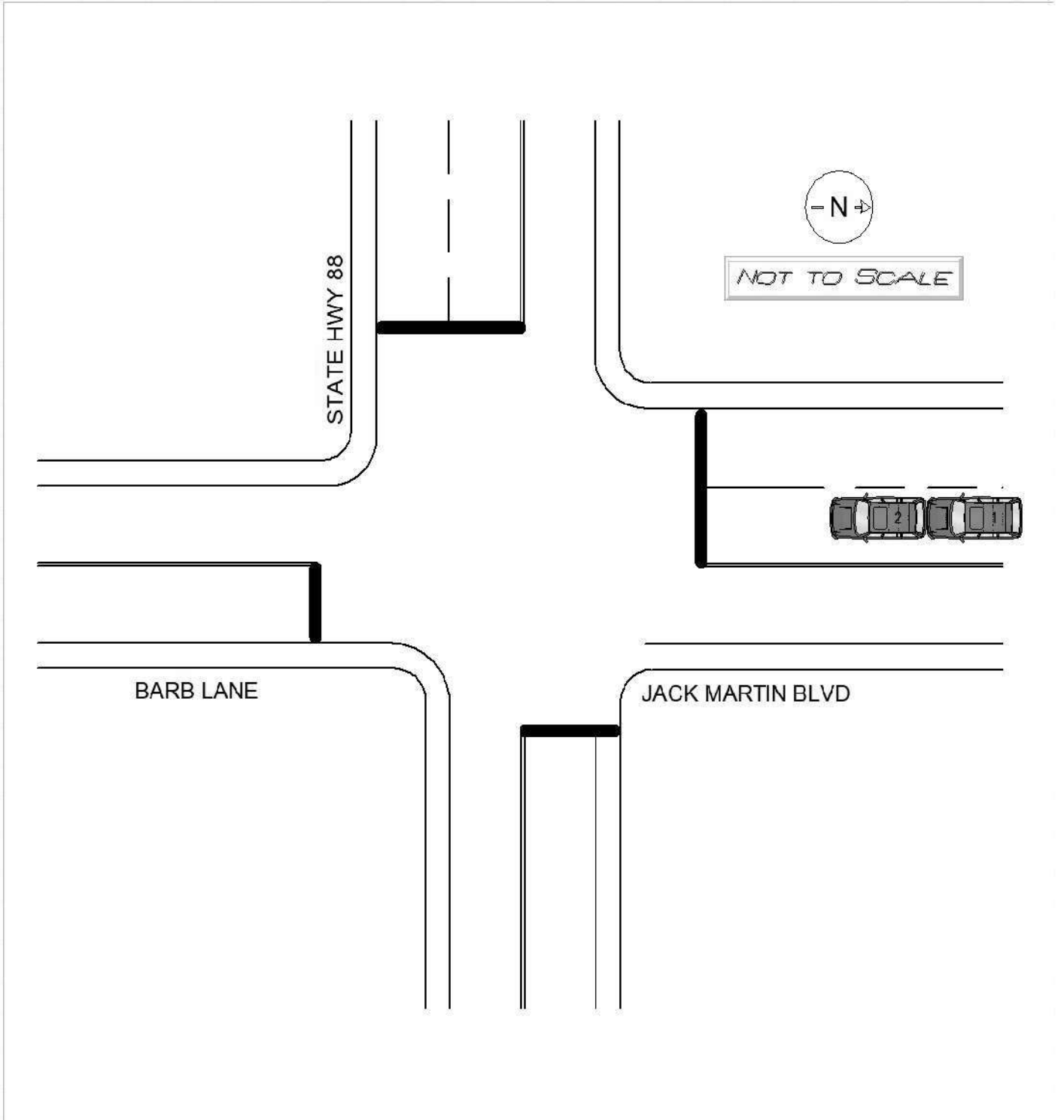
