145. Crash Description/Narrative

Vehicle #1 collided with a trailer (NJ-TVZ22W) attached to Vehicle #2 (INT/470) in a rear end crash while traveling westbound on RT 70 in the center lane.

The Driver of Vehicle #1 stated prior to the crash he was traveling straight ahead on RT 70 westbound. Driver #1 stated he could not recall how the crash occurred. It should be noted Vehicle #1 had heavy front end damage and front airbag deployment. Driver #1 had a complaint of chest pain and was ultimately transported to Kimball Medical Center for further evaluation. Based on the damage to vehicle #1 it appeared Vehicle #1 did not stop or attempt to stop prior to colliding with Vehicle #2.

The Driver of vehicle #2 stated prior to the crash he was at a complete stop in traffic in the center lane. Driver #2 stated while stopped in traffic he observed Vehicle #1 traveling behind him and was not slowing down. Driver #2 stated Vehicle #1 then struck the trailer (NJ-TVZ22) attached to Vehicle #2. The trailer sustained rear damage specifically the outer frame. There was no damage to vehicle #2 itself.

Based on my observations and statements made by both parties I found the Driver of Vehicle #1 at fault for the

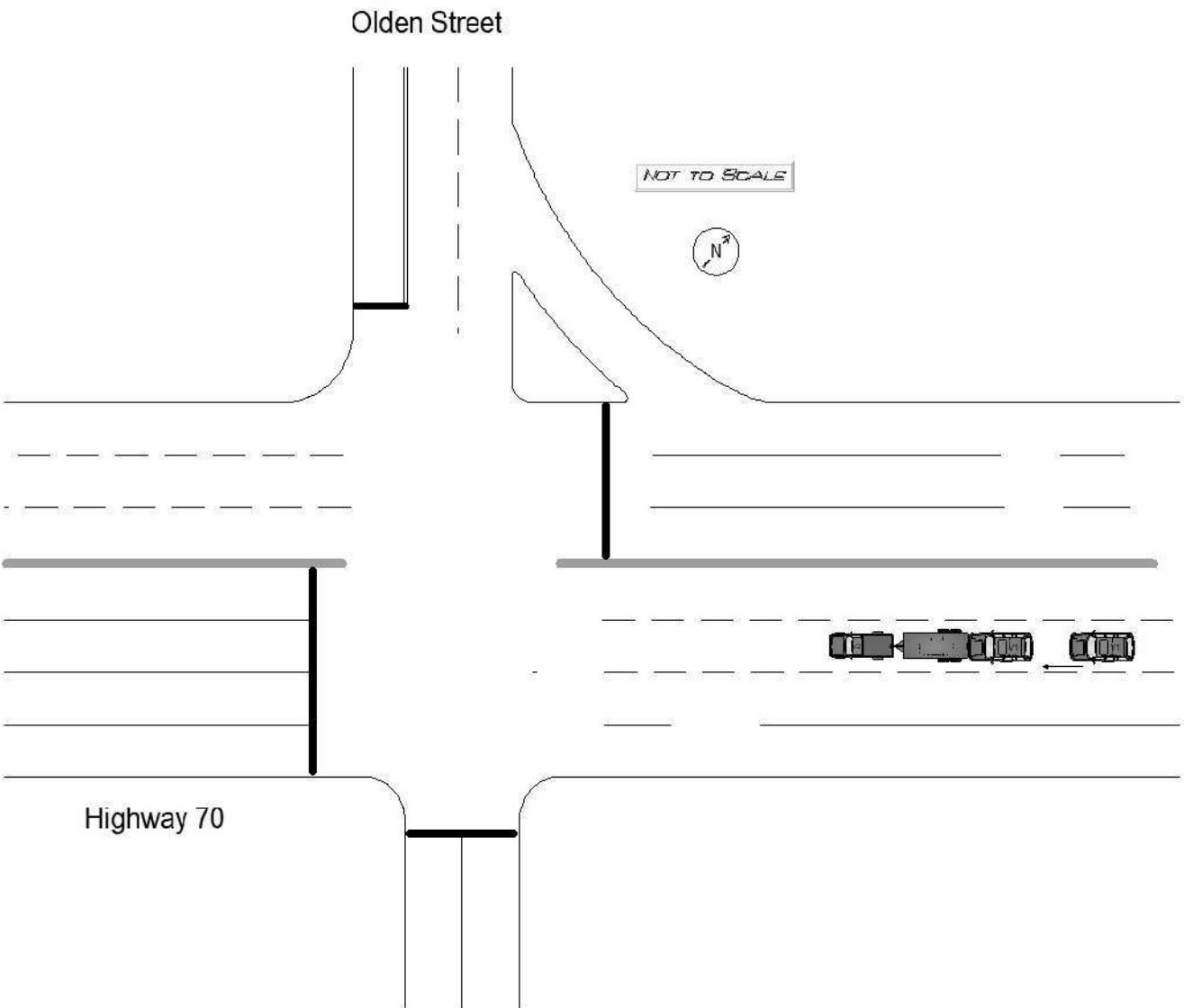
