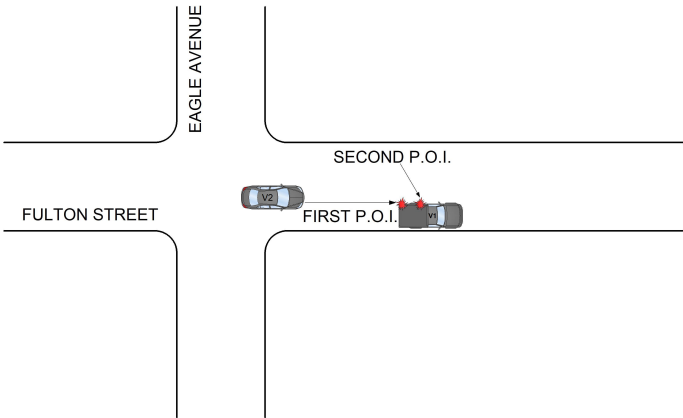
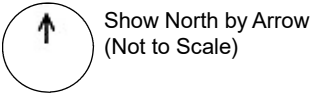

VEHICLE 1 WAS PARKED IN FRONT OF 268 FULTON STREET WHEN IT WAS STRUCK AT THE REAR DRIVER'S SIDE TAIL LIGHT, AND DRIVER'S SIDE RUNNING BOARD BY VEHICLE 2, WHICH WAS TRAVELING EASTBOUND ON FULTON STREET. VEHICLE 1 SUFFERED MINOR DAMAGE.

VEHICLE 2 WAS TRAVELING EASTBOUND ON FULTON STREET PAST THE INTERSECTION OF FULTON STREET AND EAGLE AVENUE WHEN IT SIDESWIPE VEHICLE 1 LEAVING DAMAGE TO THE DRIVER'S SIDE TAIL LIGHT AND DRIVER'S SIDE RUNNING BOARD. THE DRIVER OF VEHICLE 2 WALKED INTO POLICE HEADQUARTERS ON 12/03/22 TO REPORT THE ACCIDENT AFTER FINDING DAMAGE ON VEHICLE 1. VEHICLE 2 SUFFERED MINOR DAMAGE TO THE PASSENGERS SIDE SIDE MIRROR AND PASSENGER DOOR PANEL. THE DRIVER OF VEHICLE 2 WAS NOT INJURED DURING THE ACCIDENT.
