135 Crash Description

Vehicle #1 was traveling East bound on Route 88, in the area of Laurel Square, attempting to make a left turn into the Laurel Square parking lot. Vehicle #2 was traveling West bound on Route 88 in the area of Laurel Square.

The driver of Vehicle #1 failed to observe Vehicle #2 and made a left turn directly in front of Vehicle #2. Vehicle #1 struck the front end of Vehicle #2, causing damage to both vehicles.

The driver of Vehicle #1 stated that he did not see Vehicle #2 at all as he attempted to make the left turn into Laurel Square. The driver of Vehicle #2 stated that she was traveling West bound on Route 88 and that the driver of Vehicle #1 turned directly into her lane, striking her vehicle head-on.

There were no injuries reported. Vehicle #1 was towed from the scene and Vehicle #1 was driven from the MVA.

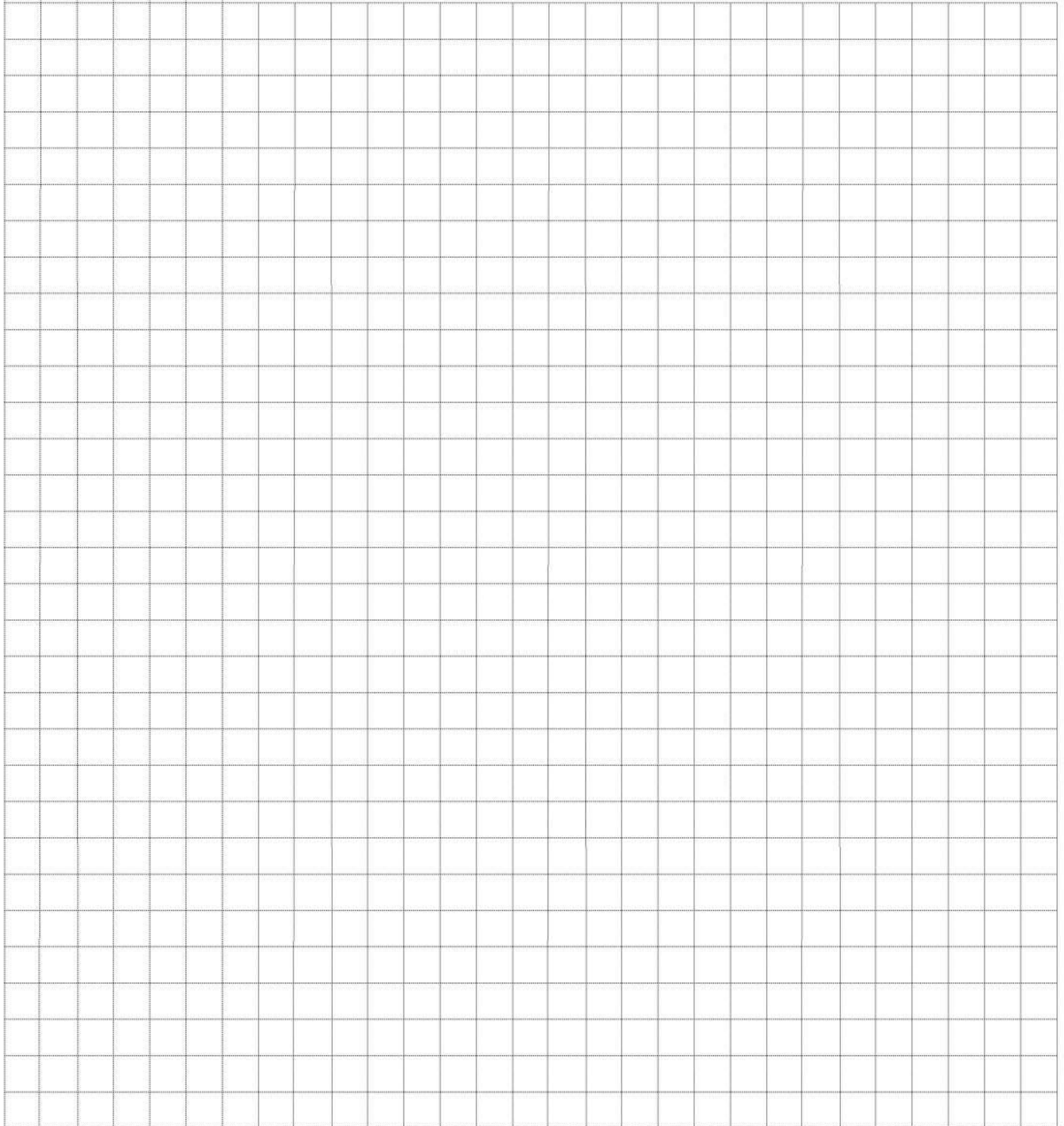
Motor Vehicle Crash Diagram
