135 Crash Description

Vehicle 01 attempted to cross over Rt 88 from the exit of Walgreens (1890 Rt 88) to the carwash (1887 Rt 88) striking Vehicle 02 which was traveling east on Rt 88.

Driver of Vehicle 02 stated she was traveling east on Rt 88 when Vehicle 01 suddenly pulled out from Walgreens exit striking the left side of her vehicle causing it to roll over on its right side and landing on the roof.

Driver of Vehicle 01 stated she was leaving Walgreens 1890 Rt 88, stopped at the stop sign, looked both ways, and then attempted to cross Rt 88 to the Car Wash. Driver of Vehicle 01 stated she never observed Vehicle 02 until she struck Vehicle 02 traveling east on Rt 88.

Driver of Vehicle 01 was issued Summonses for 39:4-97 #E15008965, 39:4-144 #E15008966.

**Vehicle 02 rear passengers are twin 5 month old boys.

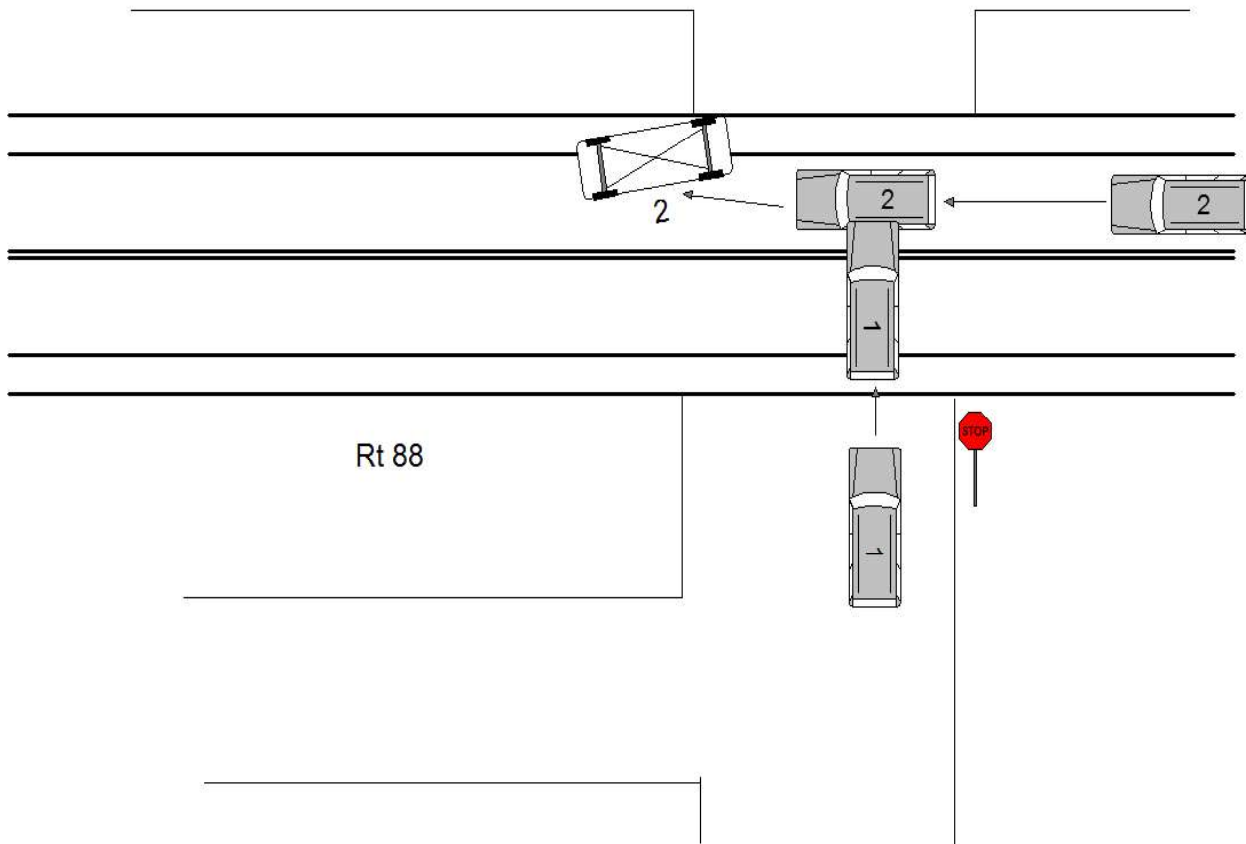
