135 Crash Description

Vehicle 1 was stopped at a stop sign waiting to turn left into the fire lane in front of Home Depot. While Vehicle 1 was waiting Pedestrian 1 stepped off of the curb to walk from the store to the parking lot area. Driver 1 did not see Pedestrian 1 and began to turn. Vehicle 1 struck Pedestrian 1 causing her to be knocked over.

Pedestrian 1 stated she saw Vehicle 1 stopped and began to cross the road to the parking lot. When she was in the middle of the road Vehicle 1 turned into her, knocking her to the ground.

Driver 1 stated he checked to make sure the lane was clear. Before turning Driver 1 was distracted by an erratic driver. After the erratic driver passed, Driver 1 began to turn. Driver 1 stated he did not see Pedestrian 1 until he noticed he hit her at.

Pedestrian 1 complained of head pain and had a small laceration on the back of her head. She was treated by Brick Police EMS on scene and transported to Ocean Medical Center.

There was no damage to Vehicle 1.
