135 Crash Description

Vehicle 1 was parking her vehicle in the parking lot of 1832 Route 88 (Laurelton Baptist Church Annex) when she failed to put her vehicle into park, let her foot off the brake and rolled into the side of the building.

Driver 1 stated she thought he car was in park when she took her foot off the brake and rolled into the side of the building. Vehicle 1 had damage to the front of it and the building had damage to the side of it. Driver 1 was not injured from the crash. The building department was notified of the crash and Ken Kiseli responded to the scene to assess the damage and stated the building was safe.

Driver 1 was taken into custody for Driving While Intoxicated (See case form report) and registered a .22 Blood Alcohol Concentration.
