135 Crash Description

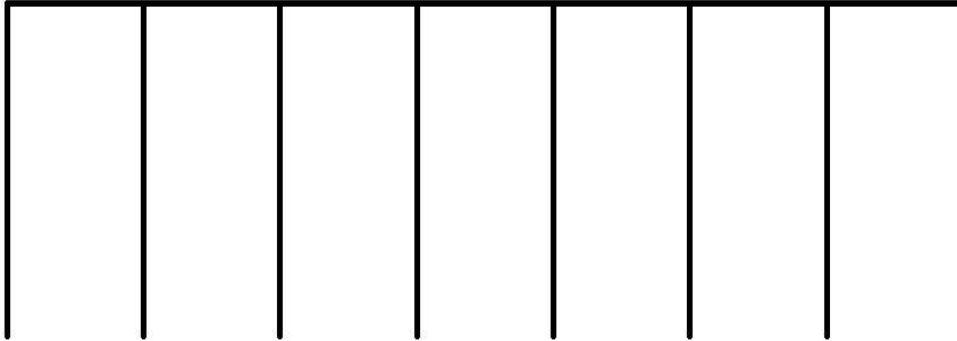
